Good evening (or morning depending on what time of day 0030 is to you) just wanted to send out some updates on force protection stuff.

1. Level I training - last week just over 200 crew members attended level 1 training, not bad but that still means that there are about a hundred people left. We will be trying to conduct training next week on Monday and Tuesday to finish everyone off. Also we will be doing training during I division next week that way anyone else needs this mandatory training can get it done before Barcelona. After the first day of training we will need to publish an email list who still needs to attend the training (any volunteers for this?) Along those lines in radm there is a new role available to all of us (atto) which will allow us to document and track the completion of level one training. Standby for future developments in this area.

2. Ports - here is a quick sked so everyone can be informed, please keep in mind we will meet 10 days prior to a port visit to discuss our inport security measures plan.
