#### **Biographical Note**

A native of Vineland, New Jersey, Admiral Beakley is a graduate of the U.S. Naval Academy, the Naval Postgraduate School, California Institute of Technology, Army Industrial College, National War College and Naval War College, and hold the degrees of Bachelor of Science and Master of Science (Aeronautical Engineering). He was designated a Naval Aviator on 24 November 1926.

Early in his career he served in the battleship *Utah*, the destroyer *Mahan*, and with fighting, torpedo and scouting squadrons attached to the aircraft carrier *Langley*, the seaplane tender *Wright*, and the cruisers *Trenton* and *Marblehead*. He was assigned to the carrier *Lexington* in 1935-1937, and for a year thereafter served as pilot, engineer officer and Executive Officer of Patrol Squadron 14-F, attached to the minesweeper *Owl*. He completed a tour of duty in the Bureau of aeronautics, Navy Department, before his assignment in July 1941 to command Fighting Squadron 5, based on USS *Yorktown*.

Fighting Squadron 5 was transferred to the USS *Wasp* in January 1942, just after the United States entered World War II, and he subsequently served as Air Group Command, Air Officer, and Executive Officer of that carrier. He was awarded the Navy Cross for extraordinary heroism in action connected with the reduction and capture of Tulagi-Gavutu-Tanambogo in the Solomon Islands area on 15 September 1942. The Legion of Merit was awarded him for exceptionally meritorious service as Assistant Operations Officer on the Staff of Commander air Force, Pacific Fleet from November 1942 to November 1943

During the latter period of the war he served as Air Officer on the Staff of the Commander in

Chief, U.S. Fleet, Washington, D.C., and in August 1945 assumed command of the carrier escort *Block Island*, which, as a member of a Naval Task Unit, steamed into Formosa to liberate 1,200 Allied military personnel from prison camps. He was detached in June 1946, and after brief duty as Plans Assistant in the office of the Chief of Naval Operations, Navy Department, and instruction at the National War college, he became a member of the Joint staff, Joint Chiefs of Staff, in July 1947. He commanded the carrier *Midway* for a year, then in July 1950, returned to the Office of the Chief of Naval Operations, to serve a year as Assistant Director for aviation, General Planning Group.

After a tour of duty as Chief of staff and Aide to the President of the Naval War College, he reported in July 1953 as Commander Middle East Force, and in January 1954 was transferred to command of the Hunter-Killer Force (later redesignated Anti-submarine Force), Atlantic Fleet. In July 1955 he again returned to the Office of the Chief of Naval Operations, this time as Assistant Director, Strategic Plans Division, and on 7 May 1956, was appointed Assistant Chief of Naval Operations (Plans and Policy), with his former assignment as additional duty. While so assigned he was promoted to the temporary rank of Vice Admiral, which he held for almost seven years.

On 28 January 1957 he became Commander SEVENTH Fleet and in November 1958 assumed duty a Deputy Chief of Naval Operations (Fleet Operations and readiness). On 21 September 1961 he reported as Deputy Commander in Chief, Atlantic Fleet and Chief of Staff and Aide to the Commander in Chief, U.S. Atlantic Fleet and the Commander in Chief, Western Atlantic. "For exceptionally meritorious service . . . during the period September 1961 to August 1963 . . ." he was awarded the Distinguished Service Medal.

On 9 September 1953, he reported, in the rank of Rear Admiral as Commandant of the First Naval District, with additional duty as Commander of the Naval Base, Boston, Massachusetts. He served as such until relieved of active duty pending his retirement, effective 1 January 1964, at which time he was advanced to the rank of Vice Admiral (the highest rank he held on active duty).
