Flight training equipment and personnel are to be transferred from Naval Air Station, Bay Shore, LI., on or about 15th December, 1917, to Naval Air Station, Key West, Florida, which, instead of being merely an operating station as originally intended, is to be used also for extensive flight training during the winter.
