C. B. Detachment #1152 - CBD 1508 (Postwar)

- 4-24-46 - CNO approves activation of CB Det 1152 at Iwo Jima. CNO considers detachment should bear same relationship to CO of Island or base as Marine Detachment on board ship bears to CO. (CNO conf disp 232300 Apr. to ComServPac).
- 5-15-46 - ComServPac directs ComMarianas to proceed with inactivation of CBMU 620 and to inactivate CB Det 1152. Personnel of CBMU to be transferred to CB Det. (ComServPac conf. disp. 012151 May to ComMarianas).
- 5-15-46 - NOTE: Authorized allowance of CB Det 1152 to be 1 officer, 30 men.
- 5-24-46 - In view rapid demobilization and abandonment or reversion bases to caretaker status do not propose activate CBD 1151 at Tinian, 1152 at Iwo Jima, 1155 at Marcus, 1160 at Majuro. (ComMarianas conf. disp 222321 May to ComServPac).
- 5-28-46 - In view ComMarianas 222321 propose establish CB Det 1152 at Subic Bay with 2 officers, 100 men (ComServPac disp 280125 May to CNO).
- 7-23-46 - CB Det 1152 activated at Subic Bay (Capt. Porter's disp. of 22 July 46) Proposed compl. 2 off. 100 men.
- 1-18-47 - Disp. 180623 dtd. 1-18-47 from ComServPac reads in part: "In accord. CNO ser. 6540 P415 dtd. 8 Oct INACTIVATE CBD 1152 Subic and concurrently ACTIVATE CBD 1508".
- 11/8/49 CBD 1508 Subic Bay, Disestablished 31 Oct. 1949, Ref. Dispatch From NS Subic to ComServPac, dtd 11/4/49 NM24/ A1-1, 0400572
