Location - Tinian Yonabaru C. B. Detachment (#1151) #1511

- 4-24-46 - CNO approves ~~in~~activation of CBDet 1151 at Tinian. CNO considers detachment should bear same relationship to CO of Island or Base as Marine Detachment on board ship bears to commanding officer. (CNO conf disp 232300 Apr to Comservpac)
- 5-15-46 - Comservpac directs ComMarianas to proceed with inactivation of CBMU 597 and activate CBDet 1151. Personnel of CBMU to be trans. to det. (Comservpac conf disp 012151 May to ComMarianas).
- 5-15-46 - NOTE: Authorized allowance of CBDet 1151 to be 1 officer, 50 men.
- 5-24-46 - In view rapid demobilization and abandonment or reversion bases to caretaker status do not propose activate CBD 1151 at Tinian, 1152 at Iwo Jima, 1155 at Marcus, 1160 at Majuro. (Com Marianas conf disp 222321 May to Comservpac).
- 5-28-46 - In view of ComMarianas 222321 propose establish CBDet 1151 (1 offr. 30 men) at Yonabaru, Okinawa. Request approval. (Comservpac disp 280125 May to CNO).

- 7-23-46 - CBDet 1151 Activated at Yona Bura. (Capt. Porters dispatch of 22 July 46)

- 8-29-46 - CBD No. 1521 assigned Port Lyautey. CNO considers det. should bear same relationship to CO as Marine Det. on board ship bears to CO. (See dispatch 291435Z 8-29-46 filed in DirLantDocks file.
- 9-10-46 - conf. dis. 290724Z NCR 9469 stated ur 020210Z Aug CBD 1151 activated this date. from NCB, Okinawa for action ComServPac.
- 22-11-47 - Request for inactivation of CBD1151 to be redesignation as CBD 1511. Rest ltr fm ComServPac to CO, NAF, Okinawa, dtd 22 Nov 47. (Ref: CNO resltr Ser3608P415 dtd 7 Nov 47)
- 12-8-47 - CBD 1151; Redesignation as CBD 1511
