- 12-29-44 - The 10th and 11th Brigades and Regs. 42 thru 48th are established. No firm assignments are to be made as yet. Will be established on direction of Cincpoa. The 4th Brigade consisting of the 2nd, 5th and 18th Regs. will be dissolved by CNO effective date to be specified by Cincpoa. Staff personnel will form the organization of the New Brigades and Regiments listed above. (CNO Sec. ltr Op30-2CK12-UOT over (SC)P16-5 over Ser. 01429730 to Cincpoa dtd 19 Dec'44).
- 1-29-45 -- Comservpac Sec. disp to Cincpoa 250147 dtd 23 Jan'45 - requests that Cincpoa 00060 of 12 Jan'45 be amended to show mounting point at Saipan for the 42nd Reg. instead of the West Coast to permit the 42nd Reg. to mount with it's batts.
- 2- 8-45 - CNO requests that Eupers assign individuals to billets in the 10th and 11th Brgs. and Regs. 42 thru 48. (CNO conf restr ltr Op30-2CK14-UOT/rc over (SC)P16-5 over Ser 49830 dtd 30 Jan'45 to Eupers)
- 2- 8-45 - CD 2619 now designated 42nd Reg. staff - this staff will report to IsCom BIVE. (CNO conf disp to Parks 311715 dtd 1 Feb'45)
- 2- 8-45 - 42nd Reg. staff (CD 2619) left U.S. 31 Jan'45 with 5 officers and 61 men (Parks Sec disp to Eupers 020015 dtd 2 Feb'45 for overseas)
- 3-8-45 --- According to Dirpadocks San Fran 15 Feb'45 report the 42nd Reg. is located at Saipan.
- 5- 8-45 - The 42nd Reg. is located at Saipan. Assigned BIVE. (Dirpadocks S.F. Sec Rep of 15 Apr'45)
- 7- 5-45 - Retention of 42nd Reg in commission no longer necessary or desirable. Accordingly, recommend that this Regiment be inactivated as soon as practicable. Further recommend that all personnel of the 42nd Reg staff be ordered to report to OinC 10th Brg for duty and ffa. This is in order that off. and men may fill shortages currently existing in 10th Brg. (CCT Okinawa Sec disp 291132Z to Comservpac)

- 9-10-45 - Comservpac reqs Cincpoa, P.'s approval to inactivate 42nd Reg. 42nd Reg presently has no off or enl Pers. 42nd Reg was released from alerted status by Cincpac Adv 220729 of Aug of higher classification. (Comservpac conf spdltr 05012 dtd 30 Aug'45 to Cincpoa, P.).
- 9-14-45 - Cincpoa approves inactivation of 42nd Reg. (Cincpoa conf spdltr (1st end) ser 032681 dtd 5 Sept'45).
- 9-18-45 - 42nd Reg is considered inactivated this date (10 Sept'45). (Comservpac conf spdltr ser 05168 dtd 10 Sept'45 to CNO).
