Location - Pearl Harbor

- 1-3-45 - The 35th (Sp) is attached to the 20th Reg. (ComservforUSPacflt Sec. ltr Ser. 55-CKW/apk over Ser. 001389 to CNO dtd 18 Dec'44).
- 2- 1-45 - The 35th (Sp) is with the 2nd Brg. (Com 14 Sec Disp to CNO 112205 dtd 18 Jan'45 - Changes in shipping designations at P.H.)
- 2-10-45 - 1 Jan'45 report of the 35th (Sp) - Batt is with the 20th Reg. and HANCB.
- 2-17-45 - The 35th (Sp) is located at Pearl Hbr. (Com 14 Sec. disp to CNO 081016 Feb'45).
- 3- 5-45 - 1 Feb'45 report of the 35th (Sp) - location not given. Report end. by the 20th Reg. and HANCB.
- 4-13-45 - 1 Apr'45 report of the 35th (Sp) - no info on location.
- 5-8-45 - 1 May'45 report of the 35th(Sp) - location not given. Report end. by 20th Reg & 2nd Brig. Company "B" is stationed on Maui on temp duty.
- 5- 8-45 - The 35th (Sp) is located at P.H. FFA. (Dirpadocks S.F. Sec Rep of 15 Apr'45)
- 5-21-45 - 1 Mar'45 report of 35th (Sp) - location not given. 50 men working at ABRD & 48 men working in a cargo assembly area established by HAB. Report end by 20th Reg & 2nd Brig.
- 6-7-45 - The 35th (Sp) is located at Oahu with the 20th Reg. (Comservpac conf epdltr 02787 dtd 29 May'45 to CNO)
- 6-13-45 - 1 Jun'45 report of the 20th Reg. - By reason of the diminishment of activities at Maui, the Co of the 35th (Sp) assigned there for duty will be brought to Iroquois Pt. It is expected this movement will be consummated during the 1st wk in June.
- 6-14-45 - 1 Jun'45 report of the 35th (Sp) - located at ABRD Iroquois Pt. 1 Co is stationed at Kahului, Maui temp.
- 7-16-45 - 1 Jul'45 report of the 35th (Sp) - located at P.H. Report via 20th Reg and 2nd Brig.

- 8-4-44 - Lt. Comdr. Boyd assigned from Davisville as OinC 35th CB (BuDocks ltr to BuPers dtd 29 Jul'44).
- 10-19-44-Davisville ordered to transfer the 35th (Sp) about 25 Oct'44 to Hueneme. (CNO Sec. Airmailgram 111601 NCR 9411 to NCTC Davisville, Budocks and Hueneme).
- 11-3-44 -The 35th (Sp) is assigned to the 8th Reg. (CNO conf. ltr Om30-2CK15-UOT over (SC)P16-5 over Ser. 01348230 to Bupers and Cincpac dtd 27 Oct'44).
- 11-28-44 - 35th (Sp) assigned to URIE. (Dirpadocks 128 Sec Ser 00465 to Comservforpacflt dtd 16 Nov'44)
- 1-29-44 - *WAS NOT LEFT U.S. YET*
 (Comserv7flt Sec. Disp. to CNO 150133 NCR 18921 dtd 24 Nov'44)
- 1-29-44 - The 35th (Sp) departed Hueneme 25 Nov'44 for Pearl Hbr. (Hueneme Sec. Disp to CNO 251857 dtd 26 Nov'44).
- 2-6-44 - Comservpac Sec. Disp. to CNO 020143 dtd 2 Dec'44 requests that the 23rd (Sp) (now assigned to the 2nd Brig. and 20th Reg.) be assigned to the 9th Brig. and 8th Reg. by CNO 111601 Oct. Request that the 35th (Sp) be ordered to 3rd Brig. for further assignment.
- 2-6-44 - CNO Conf. Disp. to Comservpac 021515 dtd 2 Dec'44 approves Disp. 020143 -- the reassignment of the 23rd and 35th (Sp)'s.
- 2-16-44 - 35th (Sp) located at Pearl Harbor and is in the 7th Brig. (Com 14 Sec. Disp. to CNO 072103 dtd 13 Dec'44)

- 7-18-45 - 1 Jul'45 report of the 20th Reg - On 16 Jun'45 one co. of the 35th (Sp) was removed from Iroquois Point. It was billeted at the Red Hill Encampment to help with stevedoring operations. The remainder of the 35th (Sp) is operating out of Iroquois Point principally at ABCD FRAY.
- 8-12-45 - 1 Aug'45 report of the 20th Reg. - 1 Co. of the 35th (Sp), 3 off. and a few 180 ser. was detached on 20 July for operations on the Island of Maui. Operations were completed and unit ret'd to the Red Hill encampment on 1 Aug'45.
- 8-13-45 - 1 Aug'45 report of the 35th (Sp) - located at Pearl Harbor. Operating at ABCD and the Navy Yard. 66 men from Det 1074 assigned to this unit. Report via the 20th Reg.
- 9-11-45 - 1 Sep'45 report of the 35th (Sp) - location not stated. Report via 20th Reg.
- 9-24-45 - Following CBs attached 20th Reg - 14th(Sp), 26th(Sp), 35(Sp), 37th(Sp). (Joining ser disp 151827 Sept'45 to CNO).
- 10-10-45 - 1 Oct'45 report of 35th(Sp) - location not stated. Report via 20th Reg. 68 men detached for leave & reassignment. 46 men ^(ser 1074) for discharge under the point system.
- 11-7-45 - 1 Nov'45 report of 35th(Sp) - location not stated. Report via 20th Reg. 14 sections of colored men have been transferred to 35th(Sp) from the 26th(Sp).
- 12-14-45 - 1 Dec'45 report of 35th(Sp) - located at Red Hill, Oahu, T.H. Report via 20th Reg.
- 1-29-46 - 1 Jan'46 report of 35th(Sp) - located at Red Hill, Oahu, T.H. Report via 20th Reg.
- 2-14-46 - Inactivation of 35th (Sp) CB to be effective upon disposal of records, accounts, and equipment. Men with less than 25 points to be transferred to 20th Reg. FFT Material Salvage Units. Those with over 25 points to be transferred to 20th Reg. for duty if not eligible for return to U.S. (OinC 20th Reg. ltr dtd 20 Jan 46 ser 93-46)
- 3-1-46 - 1 Feb 46 report of 35th(Sp) - located at Oahu, T.H. Report via 20th Reg.
