- 9-29-44 - Dets 1070, 1071, 1072, 1073 are to be established as supervisory erection crews for the installation of large diesel generators at advanced bases. These detachments are trained and awaiting assignment at the CRD Parks. (Conf. ltr. from CNO Op30-2CK15-UOT over (SC) P16-5 over Ser 01280530 dtd 23 Sep to Bupers and Budocks)
- 4-9-45 - Dets. 1071 and 1073 assigned to Guam. (Cincpoa Sec Disp to ComWesSeaFron 020243 dtd 2 Feb '45)
- 4-13-45 - When transportation is arranged by ComWesSeaFron Barks requested to order CBD 1071 and 1073 to report to IsCom DUVA. (CNO conf. disp to Parks 051911 Feb '45).
- 2-15-45 - CBD 1073 with 1 officer and 4 men departed Parks for the 5th Brg. 8 Feb '45. (Parks Sec. disp to Bupers 101730 dtd 11 Feb '45).
- 3-29-45 - Dets. 1071 and 1073 are now assigned to Det. 1046 and were enroute from 9 Feb '45 until 19 Mar '45. (Det. 1046 ltr NCBD1046/A9/RCR:jns over Ser 142 dtd 20 Mar '45 to Budocks)
- 6-27-45 - Field reports indicate inactivation Dets 1064, 1070, 1071, 1072, 1073 is desirable in order to simplify administration and operations. Propose to inactivate these units and transfer off. and men to CBMU 515 and CBD 1046 as appropriate. Request you submit your comments on above via Cincpoa. (Comservpac conf spdltr ser 03085 dtd 11 June to IsCom Guam)

- 7-14-45 - Concur with inactivating Dets 1064, 1070, 1071, 1072, and 1073. Off. and men should be ordered to report to IsCom Guam ffa. They will be assigned to CBD 1046, to CB units under operational control of Is P.W. and to units under the 5th Brg as appropriate. (IsCom Guam conf disp 06268-416 dtd 23 June to Comservpac)
- 7-26-45 - CinCPac approves the inactivation of CBDs 1064, 1070, 1071, 1072 & 1073. (CinCPac - Cincpoa Conf Spdltr Ser. 031136 dated 17 Jul '45 to Comservpac.)
- 8-21-45 - Req you direct OinC, 5th Brig to inactivate CBDs 1064, 1070, 1071, 1072 & 1073. Enl pers to be transferred to CBMU 515 and to CBD 1046 as appropriate. Inform Comservpac when inactivation is completed. (Comservpac conf spdltr dtd 25 July '45 ser 04170 to IsCom, Guam).
- 8-28-45 - CBD 1073 detached from tempdu with CBD 1046. CBD 1073 inactivated on 9 Aug '45. (OinC, CBD 1046 conf ltr ser 0374 dtd 20 Aug '45 to OinC, CBD 1073).
