10-23-47 - Activation of this date. (Navy Spd Ltr. fm NavOpBase, Guam to ComServForcesPac. dtd 23 Oct. 47)

5/1/50 Inactivation Ref: CNO Conf fifth endorsement Op-100p5/hg ser 072P100 of 17 March 1950 on OinC, Public Works Center and 30th Naval Construction Regiment Conf ltr A3-1 ser 0002 of 21 December 1949.

(Wake) 10-15-47 Activated Guam

- 4-24-46 - CNO approves activation of CB Det. 1154 at Wake. CNO considers detachment should bear same relationship to CO of island or base as Marine detachment on board ship bears to CO. (CNO conf. disp. 232300 Apr to ComServPac).
- 5-15-46 - ComServPac directs ComMarianas to inactivate 85th CB and proceed with activation of CB Det 1154. Personnel of CB to be transferred to CBDet). (ComServPac conf disp. 012151 May to Com-Marianas).
- 5-15-46 - NOTE: Author. allowance of CBDet 1154 to be 1 officer, 50 men.
- 6- 3-46 - CBD 1154 activated 20 May (OinC 85 NCB disp 210020 to Com-Marianas ) (conf).
- 3-6 -46 - CBD 1154 Inactivated 31 Jan. 47 at Wake.  
CBD 1507 Activated this date at Wake Island (3-6-47).
- 6-20-47 - In accordance with reference (a), you are hereby directed to inactivate CBD 1507 upon inactivation of NAF, Wake, on or about 15 June 1947. Ref. (a) is ComServPacs Classified Disp. 280051Z to ComMarianas.
- 10-15-47 - ACTIVATION. CB 1507 shall be under the operational and Admin. control of the Commandant, NOB, Guam, per ltr U.S. PacFlt ComMarianas, ffl2/031/A4-2 HWB:tes. Ser 19668. Personnel to be transfers from NCB 109 (deactivated). Ref: (a) CNO conf. ltr. ser. 0239P115 of 2 Sept.47. Ref(b) ComServPac Conf ltr ser.0995 of 1 Oct. 47. Authorized allowance of 4 officers and 200 men
