23RD SPECIAL BATTALION

A part of the 23rd Special, attached to the Fifth Marine Amphibious Corps, hit the beach at Iwo Jima on D-Day-plusfour. Included were Companies A and E and six men from headquarters company. A few weeks later, the rest of the outfit moved in to hump cargo on this most advanced link in the island chain to Tokyo. On V-J Day, the stevedores had again moved up, this time to Okinawa, where they were working at the Naval Operating Base. For their job in the Pacific, the men of the 23rd trained at Hueneme and put the final polishing to their dock techniques in six months at Pearl Harbor.

24 Feb 1945 - Arrived Ivo Jina.

1 Apr 1945 - Kenthly report of 23rd (5p) C.B. for March states location Iwo Jima. Cos A and B and 6 men from headquarters were attached to the 5th Ambiblous Corps for temporary duty in January. These componies arrived at target with the 8th Marine Tield Depot and landed on D-Day plus 4. The O cohelon arrived Ivo Jips 2 Harch 1945. 8 officers, and 435 men debarked on 3 Forch 1945. The first echelon arrived 7 Harch 1945. Second echelon arrived 13 March 1945. Report from the Eth Faval Construction Regiment dated 1 Arril 1945 states that 23rd (Sp) C.B. arrived Ivo Jima on 24 February 1945, that 26 men returned 10 Forch 1945 from Temporary additional duty under Co. Gen. 5th Arphibious Corps, and that 11 officers and 306 men returned 9 March 1945 from Temporary addit-1, ional duty under Co. Gen. 5th Amphibious Corps.

12 Jul 1945 - Ordered to Okinewa for duty.
