Provenance/Acquisition

The materials in this collection were either created or collected by Navy Combat Documentation Detachment 206 Reservists in order to document the attack on the Pentagon on 11 September 2001.

Administrative Note + History

Navy Combat Documentation Detachment 206 (DET 206) was established in 1991 as a reserve unit attached to the Naval Historical Center (NHC). DET 206 was established to support historical documentation of Operations Desert Shield and Desert Storm. Since its establishment, reservists assigned to the unit have deployed to commands around the world to document naval activity, missions,

conflicts, and significant events. The reservists typically gather oral histories and historical materials. In 2018, DET 206 leadership renamed the unit the Navy Combat Documentation Unit (NCDU).

In September 2001, the Naval Historical Center mobilized DET 206 reservists to document the attack on the Pentagon on 9/11 and the aftermath. The efforts of the reservists were part of the larger military response known as Operation Noble Eagle – the post 9/11 military activities that focused on securing the homeland. For almost a year, starting in the days after the attack, DET 206 reservists worked diligently to gather oral history interviews and other archival materials. In 2019, reservists from the same detachment organized the interviews and archival materials into this collection.

Scope + Content

This collection contains materials created and collected by DET 206 Reservists. The materials document the attack on the Pentagon on 9/11 and the aftermath. The 195 oral history interviews make up the bulk of the collection. All of the oral history interviews have digital audio. Almost all of the oral history interviews have abstracts and transcripts in both hard copy and digital PDF format.
