# **Scope and Content Notes**

These papers relate to the naval service of Lieutenant Vernon C. Squires, USNR who was on active duty in the reserves during World War II. These 1 feet of documents consists of biographical data, correspondence, orders, certificates, maps, and printed material.

## Biographical Sketch.

Lieutenant Squires was born on 13 June 1910 in Grand Forks, North Dakota to Vernon P. Squires and Ethel Wood Squires. He had four siblings, three brothers and one sister. He and his wife, Abbie Squires had one daughter Janie born in August 1943.

He attended the University of North Dakota and graduated with a major in mathematics and minor in physics in June 1931. Then he studied architecture at University of Minnesota, Minneapolis. He earned his bachelor's degree in architecture from Cornell University, Ithaca, New York in June 1936.

After a brief period of unemployment, he sold door-to-door and worked for different government agencies. He eventually found a job as an engineer for the Leonard Construction Co., in Chicago. There he designed the layout of a very large underground fuel oil storage depot for the Navy in Melville, Rhode Island.

In January 1942, he joined the active duty in naval reserve and worked in 1st Construction Battalion in England and France. Later, he was commissioned LT(jg) and assigned to the USS IOWA which sailed in the far Pacific. His next assignment was on the staff of Rear Admiral C. C. Badger, the Task Force Commander for the occupation of Tokyo Bay. After the war he was assigned to Naval Shipyard in San Pedro, California.

In September 1946 he was employed as a civilian at the Special Devices Center, Office of Naval Research, Port Washington, NY where he ultimately became the Director, Plant Maintenance Division. In this position, he was responsible for the maintenance, alteration, and improvement of the station which consisted of property valued in excess of \$12,000,000.

In February 1952 he worked for the U.S. Atomic Energy Commission where he started in the Reports & Control Branch, Oak Ridge Operations. He subsequently became Chief Branch, Engineer and Construction Division, for the Portsmouth Area. His responsibilities involved administrative staff work, using data and procedures, evaluating interrelationships between costs and the progress of engineering the construction of the Portsmouth Gaseous Diffusion Plant.

In November 1954, he supervised engineering service at Goodyear Atomic Corporation, Portsmouth, Ohio. He had responsibility for a substantial variety of staff services in support of complex engineering and administrative programs, embraced the development and application of procedures and media for integrating engineering activities with management objectives, and reviewed all completed engineering work to validate its non-technical phases.
