## 3. (C) Narrative of Events

a. (C) VAW 112 began 1992 with a deployment to Howard AFB, Panama in support of JTF-4 counter drug operations. During its second deployment to Panama (from 5 December 1991 to 26 January 1992) the squadron achieved great success at locating and identifying aircraft carrying illegal drugs flying north out of South America. The deployment offered excellent joint operational experience for all hands, as the command operated with a variety of naval aircraft and surface units, Air Force and Navy ground facilities, U.S. Customs assets and Air National Guard units and aircraft.

From 28 March to 11 April, the squadron established a detachment at Nellis AFB, Nevada for JADO/JEZ. VAW 112 provided command, control and communication for opposition forces and interacted with Army, Air Force, and Marine Corps units participating in joint air-to-air combat scenarios involving surface-to-air missile threats. The Golden Hawks played a vital role in developing and evaluating Army/Air Force Joint Engagement Zone procedures.

Upon completing JADO/JEZ, VAW 112 participated in QUICK FORCE '92 from 22-29 April at Nellis AFB. Two hundred aircraft from over 20 bases throughout the country were involved with this US Central Command exercise. Units from the Air Force, Carrier Air Wing 9, and Carrier Air Wing 2 worked together to enhance procedures for use in a joint air arena.

A VAW 112 detachment went to Roswell AFB, New Mexico for Operation ROVING SANDS 1992 from 10-22 May. Squadron personnel trained with units from the Army, Air Force and Marines during this highly successful joint service exercise. Operation ROVING SANDS provided training in exercise situations similar to the joint operating conditions of Operation DESERT STORM.

June began with a VAW 112 change of command ceremony. On 4 June, CDR D. B. Summerall was relieved by CDR N. L. Lilly as Commanding Officer, VAW 112. The following week, 8-19 June, the squadron deployed onboard USS Nimitz for Refresher Training (REFTRA) where the squadron trained on shipboard damage control procedures and participated in cyclic air operations.

Fleet Fighter Air Combat Maneuver Readiness Program (FFARP) provided VAW 112 aircrews with superior training with emphasis on E-2C command and control of fighter aircraft in a variety of threat scenarios. From 6-17 July, aircrew developed and polished their air control skills while building strong working relationships with air wing fighter squadrons. The FFARP detachment launched sorties from NAF El Centro and conducted the scenarios in the Yuma, AZ TACTS range.

After returning from NAF El Centro, VAW 112 made a three week detachment to NAS Fallon, Nevada for airwing weapons training. Overland strike scenarios formed the basis for operations which gave squadrons the opportunity to practice existing tactics and experiment with new ideas.

From September to December, VAW 112, as part of Carrier Airwing Nine, took part in intense battle group training in the Southern California operating

area. Intermediate Training Assessment (ITA), Competitive Training Underway Exercise (COMPTUEX), and Third Fleet Exercise (FLEETEX) were executed with great success. VAW 112 completed its work-up cycle on 17 December.

VAW 112 continued to promote safety during every evolution in 1992. The squadron flew 2344.6 accident-free hours (1438.6 day, 906.0 night, 773.4 embarked). VAW 112 conducted four all-hands safety stand downs during 1992. Most lectures were presented by experts on pertinent safety topics including hazardous material safety, drunk driving, recreational safety, and home safety.

VAW 112 had an outstanding year for enlisted retention, retaining 24 of 35 eligible members (69%). Additionally, VAW 112 saw the advancement of numerous personnel during the year: 4 to the ranks of E-7 through E-9 and 12 members to E-4, E-5, and E-6.

The end of 1992 found VAW 112 making final preparations for deployment to the Western Pacific, Indian Ocean and Persian Gulf in early 1993.
