## 2. Commander's Assessment

The Fighting Redcocks of Strike Fighter Squadron TWO TWO continued to leverage on a solid foundation from previous years to achieve an exceptionally successful 2014. The year brought a host of challenges including extensive training opportunities and detachments, culminating in a combat deployment on 22 August 2014.

The squadron began the year with Tailored Ships Training Availability (TSTA) from 15 January to 10 February. This brought the opportunity for aircrew to become more proficient operating in the carrier environment and enabled overall integration between the ship and the squadron. After this successful evolution the squadron returned to Lemoore for Unit Level Training (ULT).

Air Wing Fallon commenced on 20 March allowing the squadron to integrate with the air wing while executing Large Force Exercises (LFEs). Air Wing Fallon concluded on 18 April and was followed by another period of ULT until COMPTUEX commenced on 5 May. As a dress rehearsal for our upcoming deployment, COMPTUEX enabled the entire squadron to demonstrate they were ready to tactically fly in the carrier environment.

Returning back to Lemoore from COMPTUEX, the squadron enjoyed POM leave with friends and family prior to the lengthy deployment on the horizon. The squadron bid farewell to loved ones and embarked on the USS CARL VINSON on 22 August. The first major exercise of this deployment began on 15 September with Operation VALIANT SHIELD. Squadron aircrew flew alongside assets from the USS GEORGE WASHINGTON as well as the US Air Force providing a great opportunity to increase the interoperability of all the entities involved.

Enjoying a port visit to Singapore on 2 October, the squadron got its first taste of a foreign port call. Wrapping up this visit on 7 October, the carrier preceded further West, arriving in the Arabian Gulf and conducting turnover with the USS GEORGE H.W. BUSH on 19 October. The squadron commenced combat operations in support of Operation INHERENT RESOLVE and immediately demonstrated that their hard work would pay off. From this point until the end of the year, the squadron successfully employed over 80,000 pounds of ordinance including GBU-31, GBU-32, GBU-38, GBU-54, AGM-65E and 20mm cannon against ISIS forces over the skies of Iraq and Syria.

This period of sustained combat operations was only interrupted by two port visits to Dubai, which provided a much needed respite for the squadron as they enjoyed Middle Eastern culture and some well-deserved time off.

Wrapping up a solid 2014 the squadron enters 2015 stronger than ever and ready to continue their support of Operation INHERENT RESOLVE. Through their hard work, training and preparation the squadron was able to execute its mission flawlessly when called upon.
