ATTACK SQUADRON 22/STRIKE FIGHTER SQUADRON 22 NARRATIVE FOR 1990

1990 began with Attack Squadron 22 in the Indian Ocean onboard USS ENTERPRISE (CVN 65) during World Cruise 89/90. Ending the cruise in Norfolk, Virginia, the squadron began transition from the A-7E Corsair II to the FA-18C Hornet. Both pilots and maintenance personnel had to be trained to fly and fix the new aircraft. As part of the squadron transition all A-7E aircraft were transfered to other commands and Attack Squadron 22 (VA 22) was redesignated Strike Fighter Squadron 22(VFA 22) in May. Deliveries of the FA-18C began within the month. All squadron instructions needed to be updated and maintenance manuals obtained. Prior to the squadron flying the new aircraft a safe-for-flight inspection was held by LATWINGPAC with the squadron earning the highest score ever obtained by a transitioning command at NAS Lemoore. A Change of Command was held in August. The remainder of the year was filled with training and detachments in preparation for the next deployment.

Additional information to that listed below can be found in enclosures (4) and (5) supporting documentation and statistical data. Especially noteworthy in enclosure (4) is the submission package for the 1990 CNO Aviation Safety Award which is a comprehensive listing of VA 22/VFA 22's achievements in 1990. Statistical data, including flight hours and missions flown, can be found in enclosure (5) under weekly and monthly training reports.

Highlights of the year include:

January

VA 22 began 1990 onboard USS ENTERPRISE (CVN 65) enroute to the Indian Ocean. Events of early January were highlighted by a weapons week off the island of Diego Garcia and the traditional "Shellback Initiation" as the ship crossed the equator. The remainder of January was spent on station in the Indian Ocean, conducting training and flying in and around the Persian Gulf in support of National Policy.

February

February saw VA 22 and USS ENTERPRISE (CVN 65) leave the Persian Gulf area and began the long trip around the horn of Africa. Flight operations were held to a minimum during the transit and by the third week of February VA 22 was in Rio De Janerio, Brazil. The month came to a close with the ship again underway as the squadron held a safety stand down.

March

Following four days of flight operations, the squadron made a port call to St. Thomas, Virgin Islands. Soon after leaving St. Thomas, VA 22 flew all their aircraft off the carrier to the west coast. The remainder of cruise was filled with the Tiger Cruise, the squadron off load in Norfolk, Virginia and the airlift back to NAS Lemoore, California. Once in Lemoore, the squadron immediately began sending personnel through the FA-18 training track in preparation for the squadron's transition to the Hornet.

APRIL

The month of April was similar to March, with Pilots and maintenance crews attending FA-18 schools and the transfer of squadron aircraft to other commands. By the end of the month, VA 22 had transfered all of their A-7E aircraft.

MAY

On 3 May, the squadron held a redesignation ceremony and ATTACK SQUADRON TWO TWO became STRIKE FIGHTER SQUADRON TWO. Once again, schools dominated the month. 30 May saw the arrival of the squadron's first FA-18C Hornet.

JUNE

June saw the arrival of two more FA-18C aircraft. The squadron also began receiving fully trained FA-18 personnel back from FRAMP schools. The maintenance department began preparing for their Pre Safe-for-Flight Inspection.

JULY

Schooling dominated the month as the squadron continued to train for their new aircraft. On 5 July, a Pre Safe-for-Flight Inspection was held. Another FA-18C was delivered on 6 July. MTIP testing rounded out the month's activities.

AUGUST

VFA 22 began the month of August with a Safety Survey on the first, and a Change of Command on the ninth. In the Change of Command, CDR. Robert Darwin took the helm as "Redcock One" from Dale Doorly. Mid-month saw the squadron pass the Safe-for-Flight Inspection with the highest grade ever scored in LATWINGPAC. The "Redcocks" scored "Outstanding" in 37 of 43 inspection areas. Two more aircraft arrived in August, and daily flights in the squadron began on 20 August 1990. The month ended with all personnel attending a phone security brief.

SEPTEMBER

September began with the "Redcocks" flying their first Night Vision Goggle sortie on 4 September. Two more aircraft arrived this month and the squadron sent a small detachment, including one aircraft and pilot, to NAS Miramar for Top Gun training, a first for the "Redcocks".

OCTOBER

VFA 125 returned three "Redcock" aircraft on loan for pilot training, bringing the squadron total to nine FA-18C aircraft onboard. Squadron continued training, participating in two exercises involving other commands and services. Operation Coronet Goldrush saw "Redcock" FA-18's oppose a USAF strike protected by F-15's. Operations with the USS Arkansas off the coast of California tested our Link 4 capabilities.

NOVEMBER

November was extremely busy with maintenance preparing for the CWTPI, completed on the 15th. An overall grade of Outstanding was achieved with 881 out of 900 points being scored and zero major/zero minor discrepancies. The pilots completed SFARP ground school and shortly after Thanksgiving the squadron detached to NAS Fallon for the flying portion of SFARP.

DECEMBER

The month of December opened with VFA 22 in Fallon, Nevada, completing their SFARP detachment. Proloads began in preparation for the January NWAI. Pilots entered AARP ground school in preparation for the upcoming AARP detachment in El Centro, California next year.
