2. Commander's Assessment

The Fighting Redcocks of Strike Fighter Squadron TWO TWO had a banner year in 2013. Despite facing the challenge of an uncertain schedule, they succeeded in improving upon already strong foundations in both maintenance practices and tactical prowess, finishing the year stronger than they began it.

The Redcocks kicked off 2013 in preparation for a scheduled fall deployment. However in February, shortly after starting the Strike Fighter Advanced Readiness Program (SFARP), their deployment aboard USS CARL VINSON (CVN 70) was indefinitely delayed due to funding concerns. The detachment to NAS Fallon for training originally intended to complete SFARP was repurposed into a Unit Level Training (ULT) period. While not officially part of the Fleet Readiness Training Plan (FRTP), this detachment provided invaluable air-to-air and air-to-surface training. Similarly in May, an at sea period aboard USS CARL VINSON (CVN 70) originally planned for Tailored Ship's Training Availability (TSTA) was instead used for carrier qualification and ULT training for both the squadron and ship.

With deployment delayed and facing an uncertain future, the Redcocks began to refocus. Redcock One, CDR Richard "Bean" Hill, decided the squadron's attention needed to be given to ensuring his aircraft were well prepared for when the FRTP was eventually turned back on. Thus, a delicate balance was struck between spending the necessary time on depot level maintenance and maintaining aircrew proficiency. Within these constraints, the Redcocks still managed to complete all required training evolutions including the qualification of two new Forward Air Controller (Airborne) (FAC(A)) crews. Consequently, when word came down in midsummer that the FRTP would begin again in October, VFA-22 was well positioned for success.

The work-up cycle commenced with SFARP lectures in October. Follow on SFARP flight events out of NAS Lemoore and NAS Fallon instructed by Strike Fighter Weapons School Pacific (SFWSP) increased the squadron's tactical proficiency to a point not seen since early 2012. With the first stage of the FRTP complete, the Redcocks were ready to begin 2014 with Field Carrier Landing Practice (FCLP) flights and another detachment to the USS CARL VINSON (CVN 70) for TSTA.

Overall, 2013 was a year fraught with uncertainty. However the Sailors and Officers of Strike Fighter Squadron TWO TWO faced this challenge with poise and are heading into 2014 well positioned to successfully complete the FRTP and begin deployment.
