## CY 01 FLEET SUPPORT

4. Narrative.

The Saints of Fighter Squadron Composite 13 completed a demanding and rigorous schedule for calendar year 2001. As the Navy's premiere reserve squadron, the Saints flew over 5300 hours and 5100 sorties supporting one Key West Det, 4 CVW's, 11 FRS detachments, and 5 SFARP detachments during which 11 fighter squadrons were expertly trained. The pinnacle of the year's operational performance was October, in which VFC-13 executed a quadruple SFARP concurrent with a VFA-125 FRS Det, producing a record breaking 630 flight hours and 610 sorties. With this

intense core sortie support schedule, the Saints continued to seek ways to further support the fleet and Naval Aviation. VFC-13 supported Fighter and Fighter Attack training missions ranging from Lemoore squadron level SFWT sorties to Battle Group training off the coast of San Diego to LFE missions in Hill AFB, The Saints' dedication to fleet support increased the Utah. fleet support ratio from 42% to well over 65%. The intense operational achievements of the Saints highlights the successful year experienced by all departments. The morale remained undaunted through this rigorous schedule, cancer cluster, and contract maintenance transition. The Saints achieved a 100% enlisted retention rate and recognized individual performance awarding 17 medals and 2 letters of commendation. The Saints continued to emphasize safety, completing four safety standowns, three safety surveys, and a NAVOSH survey in calendar year 2001. The VFC-13 team also continued to look for improvement in the The squadron aggressively pursued and implemented an future. upgrade program including radar and jamming programs, as well as the upcoming integration of Swiss F-5's which will assure Saints' success confidently into the 21<sup>st</sup> century. The Saints' uncompromising devotion to mission guality and efficiency has once again set the standard in naval aviation and is reflected in the squadron's tremendous reputation among fleet customers.
