COMMAND COMPOSTION AND ORGANIZATION

USS AUSTIN is an Amphibious Transport Dock ship designed to transport and land ashore her complement of up to 900 Marines and their equipment by both helicopter and surface amphibious landing craft. AUSTIN carries enough equipment and supplies to sustain her assault force ashore for 15 days, unsupported.

USS AUSTIN is homeported in Norfolk, Virginia, and under the administrative command of Commander, Amphibious Group TWO, RADM Sutton.

Narrative

The year 1999 commenced with AUSTIN having just returned from deployment in December 1998, and moored Norfolk, Virginia. The Crew was on holiday stand-down, enjoying well-deserved time off with their families.

In February, the ship transited north, to the Yorktown Naval Weapons Station and off-loaded weapons in preparation for the upcoming overhaul.

On 22 March AUSTIN entered the NORSHIPCO Shipyard and began a three-month overhaul period. The ship underwent extensive work in each Main Machinery Room, including a strength and integrity check of both boilers, numerous pump overhauls, and an overhaul of the evaporators. Piping to and from the CHT pumps rooms were replaced. Of particular note was the installation of a Rigid Hull Inflatable Boat on AUSTIN's port side, aft. Upon completion of the overhaul, on 22 and 23 June AUSTIN conducted a very successful sea trial. All the systems that were worked on in the shipyard were tested satisfactorily.

On 01 July CDR W. W. Crow relieved CDR R. S. Callas as the Commanding Officer of AUSTIN. Later in July AUSTIN traveled to Boston, Massachusetts, for liberty. While there, AUSTIN Sailors gave many tours of the ship, and successfully projected a very positive Navy image to the community.

Upon returning from Boston, AUSTIN began her Inter-Deployment Training Cycle. The months of August and September saw AUSTIN underway several times to complete the Basic Phase requirements of the Inter-Deployment Training Cycle. LCDR J. E. Hines relieved CDR J. E. Tranoris as AUSTIN'S Executive Officer on 02 September. On 15 September AUSTIN sortied with all of the ships homeported in Norfolk in order to avoid Hurricane Floyd. Three days later, despite having been caught in the storm, AUSTIN returned to Norfolk unscatched.

In October, AUSTIN began Preparing for the Final Evaluation Period (FEP), and the transition from the Basic Phase of Training to the Intermediate Phase. On 12 October AUSTIN once again transited to Yorktown, where a successful ammunition onload was conducted. AUSTIN returned to Norfolk on 29 October.

In early November AUSTIN Sailors were called upon to put their training and experience to work. On 04 November AUSTIN left Norfolk enroute to the Nantucket Shoals, off the coast of Massachusetts, to provide support as the Command and Control Ship for the Egypt Air Flight 990 recovery efforts. AUSTIN remained on station through 18 November, pulling into Newport, Rhode Island several times to off-load recovered part and transfer personnel. While in Newport, Austin embarked FBI and NTSB detachments to assist in and help direct the recovery efforts. Once the flight-data and voice recorders were recovered, AUSTIN moored in Newport for four days. The FEP inspection team arrived on 18 November. AUSTIN departed Rhode Island on the 18th and successfully completed FEP during her transit back to Norfolk. On 19 November AUSTIN arrived in Norfolk. The rest of the year was spent inport.

Technicians began installing the Navy's IT-21 communications upgrade in December. The last part of December was spent with the ship in a Holiday Leave period for Christmas and New Year's Day. AUSTIN was award the Maritime Excellence Black E, the Engineering Survivability Red E, the Combat Systems Excellence Green E, and the Supply/Logistics Excellence Blue E in recognition of her superior performance during 1999. AUSTIN completed the year ready to face all challenges that face her during the first year of the next millennium.
