2007 turned out to be a challenging and successful year for the Crew of the USS CARR. CARR spent the first half of 2007 preparing for deployment by completing workups with KSGESG and completing Engineering Operational Certifacation in June. Highlights of our six months of preparations included visiting Palm Beach, FL for Sunfest in May. Prior to getting underway for deployment, CARR hosted a Family Day Cruise for family members and friends. Mr. Jeffery Rush of Oklahoma, Paul Henry Carr's (ship's namesake) nephew, joined CDR Lang in celebrating the 22nd Anniversery of CARR's Commissioning. On August 1, CARR set sail for deployment to the Arabian Gulf. Upon reaching the Gulf, CARR assumed duties operating in the Northern, Central, and Southern Arabian Gulf during its time in the region.

CARR operated within Iraqi territorial waters with Coalition Task Force 158 as part of Operation Iraqi Freedom between September and December. CARR assumed the duties of Maritime Interdiction Operation Commander, Scene of Action Coordinator, Surface Warfare Commander, Electronic Warfare Commander, and Commander Task Group 158.1 at various periods for the defense of the Al Basra and Khawr Al Amaya Oil Terminals which provide over 85 percent of Iraq's GNP and 2.4% of the world's daily oil needs. Additionally, CARR hosted two Iraqi Naval Officers onboard to conduct training on Oil Platform operations and communications.

While acting as Scene of Action Coordinator, Surface Warfare Commander, Electronic Warfare Commander, and Commander Task Group 158.1, CARR coordinated the Med-Evac of an injured Iraqi fisherman from the North Arabian Gulf on November 26 with medical assistance provided by the RSS Persistence of Singapore. CARR Sailors coordinated the movement of 15 small boats, 3 helocopters, and 8 US and foreign warships in addition to conducting small boat operations with CARR's RHIB and conducting flight quarters for three aircraft.

While transitting outbound of the Strait of Hormuz, three IRGCN Boghammers approached CARR and pointed their weapons at CARR. One approached CARR's bow and turned away when CARR sounded the ship's whistle. This incident turned out to be the second of three similar incidents involving US Navy Warships and IRGCN in the Strait of Hormuz during December 2007.

CARR received BZ from the Commander of ENTESG, Commander KSGESG, and Commander of CTF 158 for our successful operations in the Northern Arabian Gulf. Additionally, CARR's ASW Team placed first in the Fleet during the third and fourth quarter of SIPRTOP' acoustic grams analysis.

Overall, 2007 proved to be a successful year for CARR Crew which overcame every challenge with Courage, Will and Determination.

USS CARR (FFG 52) began 2007 preparing for a six month deployment to the Fifth and Sixth Fleet Area of Operations in the Arabian Gulf and Mediterranean Sea under the Command of CDR George E. Lang, Jr with the KEARSARGE EXPEDITIONARY STRIKE GROUP (KSGESG). CARR participated in numerous exercises, workups, and certifications in preparation for deployment with KSGESG. CARR began deployment on August 1, 2007 and returned to Norfolk, Virginia on January 25, 2008 after participating in Operation Iraqi Freedom, Operation Enduring Freedom, and Operation Sea Dragon in the Arabian Gulf.

CARR started 2007 inport Norfolk, Virginia during Holiday Standdown preparing for MOB-E and deployment with KSGESG. In January, February, and March, CARR completed MOB-E trials underway off the Virginia Capes. In April, CARR completed predeployment workups with the KSGESG while underway off the Virginia Capes and INSURV while inport Norfolk, Virginia. In late April, CARR embarked HSL 42 DET 10 for Week One Work-ups (WOWU) led by LCDR William Taft which included two SH-60B Sea Hawk Helicopters, seven pilots and twenty aircraft maintainers. In May, CARR again completed MOB-E trials enroute to Florida with KSGESG. In May, CARR visited Palm Beach, Florida for Sun Fest 2007 where the city hosed CARR and Crew for the festival. After leaving Palm Beach, CARR conducted COMPTUEX with KSGESG underway off the coast of North Carolina.

In June, CARR made final preparations for deployment including a weapons onload at Naval Weapons Station Yorktown and CERTEX with the KSGESG underway off the Virginia Capes in which CARR completed MOB-E 6 and Engineering Operations Certification.

July consisted of POM Leave for CARR's Crew, a maintenance availability and a Family Day Cruise for the crew's family and friends. Mr. Jeffery Rush, Paul Henry Carr's nephew, joined CDR Lang to celebrate the 22nd Anniversary of the Commissioning of USS CARR on July 27, 1985.

On August 1, CARR began its deployment with KSGESG in the company of USS KEARSARGE (LHD-3), USS GUNSTON HALL (LSD 44), USS PONCE (LPD-15), USS

VICKSBURG (CG-69), and USS PORTER (DDG-78) enroute to the Fifth and Sixth Fleet Area of Operations.

While in the Mediterranean, CARR visited Augusta Bay, Italy and Limassol, Cyprus in August. In Limassol, thirty Sailors cleaned up historic Kourion Beach in Southern Cyprus with volunteers from the U.S. Embassy in Nicosia marking the first time that the US Navy and US Embassy in Nicosia worked together on a community relations project. Additionally, CARR sailors gave forty members of the US Embassy and their families tours of the ship.

Upon entering the Fifth Fleet Area of Operations, CARR conducted Maritime Security Operations in support of regional stability with Coalition Partners in the Red Sea, Gulf of Oman, Indian Ocean, Horn of Africa, Arabian Sea, and Southern, Central, and Northern Arabian Gulf in support of Operation Iraqi Freedom, Operation Enduring Freedom, and Operation Sea Dragon in the Arabian Gulf.

In late August, CARR participated in a bilateral exercise with a regional Middle Eastern partner. The exercise was designed to increase cooperation and interoperability between the two navies and focused on VBSS tactics and training.

From September until December, CARR conducted Maritime Security Operations and Interaction Patrols (IPATS) in the Central, Southern, Northern Arabian Gulf as part of Operation Sea Dragon. CARR's Visit Board Search and Seizure (VBSS) Team distinguished itself by leading KSGESG in Approach and Assist Visits (AAVs) with 130. These operations involved sending CARR's boarding team via ship's RHIB to local fishermen, fishing in dhows, the traditional Persian Gulf craft. Oftentime, CARR would maneuver within a concentration of dhows, and the boarding team would visit up to ten dhows per hour. Over a period of two days in late October, CARR's boarding team made about 100 AAVs. Most successful AAVs were conducted with a translator (farsi and hindi) who were able to assist the boarding team and rapidly identfity any problems that the fishermen might have faced, especially piracy. On several occasions, CARR assisted local fishermen with mechanical and medical emergencies.

Additionally, CARR operated within Iraqi territorial waters with Coalition Task Force 158 as part of Operation Iraqi Freedom intermittently between September and December. CARR assumed the duties of Maritime Interdiction Operation Commander, Scene of Action Coordinator, Surface Warfare Commander, Electronic Warfare Commander, and Commander Task Group 158.1 at various periods for the defense of the Al Basra and Khawr Al Amaya Oil Terminals which provide over 85 percent of Iraq's GNP and 2.4% of the world's daily oil needs. Additionally, CARR hosted two Iraqi Naval Officers onboard to conduct training on Oil Platform operations and communications. While acting as Scene of Action Coordinator, Surface Warfare Commander, Electronic Warfare Commander, and Commander Task Group 158.1, CARR coordinated the Med-Evac of an injured Iraqi fisherman from the North Arabian Gulf on November 26 with medical assistance provided by the RSS Persistence of Singapore. CARR Sailors coordinated the movement of 15 small boats, 3 helocopters, and 8 US and foreign warships in addition to conducting small boat operations with CARR's RHIB and conducting flight quarters for three aircraft.

On October 6, 2007, while conducting Maritime Security Operations off the Horn of Africa to deter Human Smuggling and piracy, CARR initiated 167 new Shellbacks as CARR crossed the Equator at 2135 Zulu at 00 00 00/046 50 70 E.

On October 27, CARR conducted a change of command in the Central Arabian Gulf when CDR Mark V. Metzger relieved CDR George E. Lang, Jr. as Commanding Officer.

CARR visited Mina Salman, Bahrain in September and again in November to complete a major emergent repair to the Sonar Rubber Dome. CARR visited Dubai, UAE in December upon completion of operations in the Arabian Gulf. While transitting outbound of the Strait of Hormuz, three IRGCN Boghammers approached CARR and pointed their weapons at CARR. One approached CARR's bow and turned away when CARR sounded the ship's whistle. This incident turned out to be the second of three similar incidents involving US Navy Warships and IRGCN in the Strait of Hormuz during December 2007. In late December, CARR escorted USS PHILIDELPHIA (SSN-690) from the Red Sea to the Mediterranean Sea through the Suez Canal while transiting from the Fifth Fleet to the Sixth Fleet area of responsibility.

What began as a successful year for CARR ended successfully as CARR celebrated New Year's Eve 2008 inport Haifa, Israel on its return voyage home to Norfolk, Virginia.
