2008 turned out to be a busy and challenging year for the Crew of USS CARR as we completed one deployment and spent the next ten months preparing for our next deployment. CARR began the year in Haifa, Israel under 6th Fleet transiting home from a 5th and 6th Fleet Deployment with KEARSARGE EXPEDITIONARY STRIKE GROUP. On the voyage home, CARR stopped in La Spezia, Italy and Malaga, Spain. Off the

coast of Malaga, CARR rescued 8 Algerian mariners in distress during a storm. In Malaga, CARR sailors helped clean the Cudeca Cancer Care Hospice, a charity that provides specialized care to patients suffering from non-curative cancer in the Malaga province. On 25 Jan 08, CARR returned to Norfolk, VA to be greeted by 250 family and friends marking the completion of our deployment with KEARSARGE EXPEDITIONARY STRIKE GROUP that began on 1 Aug 07.

In April, CARR provided security as USNS GRAPPLE (T-AFT 173) towed the ex-USS HYMAN G. RICKOVER from Portsmouth, NH to the Panama Canal from April 2-24. CARR visited Guantanamo Bay Navy Base to conduct Force Protection training, refuel, and onload stores. In May, CARR conducted port calls to Caribbean nations and ports in support of Theater Security Cooperation. CARR visited St. Thomas, US Virgin Islands, Bridgetown, Barbados, Port of Spain, Trinidad and Tobago, Curacao, Netherlands Antilles. In Barbados, CARR trained Barbados Coast Guard on VBSS tactices and donated toys and supplies to Dame Olga Lopes-Seale as part of Project Handclasp. CARR culminated its Caribbean underway by participating in Caribbean Days 2008 in Curacao, Netherlands Antilles with Dutch, British, French, Colombian, and Venezulian navies to celebrate naval heritage in the Caribbean. The ships paraded in formation into Curacao's harbor and conducted demonstrations, gave tours, and hosted events in support of Theater Security Cooperation initiatives.

Between June and August, CARR completed its Unit Level Training and Readiness Assessment Certifacation (ULTRA-C), Unit Level Training and Readiness Assessment Engineering (ULTRA-E), Engineering Operation Certifacation (EOC), Supply Maitenance Certifacation (SMC), 3M Certifacation, Search and Rescue (SAR) certifacations in preparation for deployment. CARR was one of two Frigates on the East Coast to complete the EOC during ULTRA-E.

In September, CARR entered its CNO Availability at Marine Hydraulic International Shipyard in Norfolk, VA and worked hard to get the ship ready on time. CARR Sailors refurbished the Crew's Lounge and Engineering Berthing, in addition to numerous preservation projects. Additionally, CMDCS Bobbie Anderson relieved CMDCM Paul Alaniz as Command Master Chief and LCDR Philip Engle relieved LCDR Jason Alleyne as Executive Officer.

On 5 Dec 08, two days after Sea Trials, CARR embarked 120 guests to host a Family Day Cruise and Change of Command Ceremony for Destroyer Squadron Two (DESRON TWO) underway in the Virginia Capes. Captain Brad Williamson relived Commodore Larry Tindal as Commander, Destroyer Squadron Two on CARR's flight deck with Rear Admiral John Christenson presiding. Mr. Jeffery Rush, Paul Henry Carr's nephew, and his wife, Jane, flew from Tulsa, OK to participate in the event as well.

Overall, 2008 proved to be a busy and successful year for CARR as it faced every challenge with Courage, Will, and Determination.

CARR celebrated New Year's Eve in Haifa, Israel before making port calls to La Spezia, Italy and Malaga, Spain. Off the coast of Malaga, CARR rescued 8 Algerian mariners in distress during a storm. In Malaga, CARR Sailors participated in a community relations project at Cudeca Cancer Care Hospice. The charity provides specialized care to patients suffering from non-curative cancer in the Malaga province. For the past fifteen years, the charity has provided free hospice care to over 5,000 patients and trained for 1000 health professionals. On January 25, 250 friends and family members greeted CARR Sailors when they returned home to Norfolk, Virginia. In February, CARR conducted a Post Overseas Movement Leave Period.

In April, CARR provided security as USNS GRAPPLE (T-AFT 173) towed the ex-USS HYMAN G. RICKOVER from Portsmouth, NH to the Panama Canal from April 2-24. CARR visited Guantanamo Bay Navy Base to conduct Force Protection training, refuel, and onload stores. In May, CARR conducted port calls to Caribbean nations and ports in support of Theater Security Cooperation. CARR visited St. Thomas, US Virgin Islands, Bridgetown, Barbados, Port of Spain, Trinidad and Tobago, Curacao, Netherlands Antilles. In Barbados, CARR trained Barbados Coast Guard on VBSS tactics and donated toys and supplies to Dame Olga Lopes-Seale as part of Project Handclasp. In Trinidad, twenty CARR sailors spent the day repainting an elementary school. CARR culminated its Caribbean underway by participating in Caribbean Days 2008 in Curacao, Netherlands Antilles with Dutch, British, French, Colombian, and Venezulian navies to celebrate naval heritage in the Caribbean. The ships paraded in formation into Curacao's harbor and conducted demonstrations, gave tours, and hosted events in support of Theater Security Cooperation initiatives.

Following CARR's Caribbean Cruise, CARR completed ULTRA-C in June with high marks and regards from ATG. The electricians overcame a major casualty, a salt water leak onto an Automatic Bus Transfer, and got the ship undereway to successfully complete ULTRA-C. Two weeks later, CARR's engineers completed ULTRA-E and the Engineering Operation Certifacation (EOC), one of two frigates on the East Coast to

complete EOC during ULTRA-E, after two weeks of intense preparation. On the week of June 23-28, CARR embarked 17 Midshipmen from NROTC Units from around the country as part of their Career Orientation and Training for Midshipmen (CORTRAMID). They conducted numerous events including live fire exercises, an ASW Scenario, Divisional Tactics, and RHIB races.

In July, CARR participated in Joint Task Force Exercise 08-4 "Operation Brimestone" as the Opposition Force with the Theodore Roosevelt Carrier Strike Group and Iwo Jima Expeditionary Strike Group. The Exercise included over 80 aircraft, 30 ships, and 15,000 personnel including ships from the French, British, Peruvian, and Brazilian navies and focused on intergrated training.

In August, CARR completed its Search and Rescue (SAR) and 3M Certification while the Supply Department earned its certification during Supply Maintenance Certification (SMC).
