## 2. Commander's Assessment

USS CHAFEE departed for a three-month surge deployment to Seventh Fleet on 5 April 2010. After a brief stop for fuel in Guam, USS CHAFEE arrived in Sembawang, Singapore, on 20 April and held a planned Change of Command ceremony 24 April. CDR Chase Patrick relieved CDR Heedong Choi as Commanding Officer. The ship very quickly transited the Singapore Straits and the Strait of Malacca, proceeding to the vicinity of Goa, India, for MALABAR 2010, an annual US-Indian Navy exercise intended to enhance bilateral ties and increase interoperability with Indian forces. The next two months were spent patrolling the South China Sea, conducting presence operations, freedom of navigation, special mission ship escort of USNS assets, as well as local

engagement with maritime partners operating in the area. A Theater Security Cooperation engagement visit to Kota Kinabalu, Malaysia, located on the northwest side of Borneo, was also performed. The ship successfully completed the Naval Surface Fire Support (NSFS) Firing Exercise (FIREX) II qualification on Oki-Daito Jima (ODJ) Island, south of Okinawa. At the time of qualification, CHAFEE was one of only two ships in the last seventeen attempts to successfully certify on ODJ. Immediately upon return to CHAFEE's homeport of Pearl Harbor, CHAFEE sailed again to participate in Rim of the Pacific 2010 as a member of the RONALD REAGAN Strike Group "Ring of Steel".

While CHAFEE operated in the South China Sea, an unprecedented at-sea engagement with a Russian Surface Action Group resulted in a day-long series of exercises with an overall positive tone. The Russian Surface Action Group interaction was cited by COMMANDER TASK FORCE SEVEN ZERO as priceless... a "great example of fostering relationships between those who share the seas".

In 2010, CHAFEE enjoyed a remarkable streak of success in virtually every milestone in operational, training and maintenance categories, a reflection of the fidelity paid to the necessary planning, preparation, rehearsals, and execution. An outstanding 3M Assessment in August 2010 for an overall score of 93.2% came immediately on the heels of the return from deployment, and in which every work center scored passing results. In August, CHAFEE was selected as a CAPTAIN EDWARD F. NEY Food Service Excellence Award finalist. A superbly managed 15-week Selected Restricted Availability/CNO Availability, featuring critical path installations of the MK 38 25MM gun weapon system and the AN/SQQ-89A(V)15 system, yielded solid teamwork in CHAFEE's maintenance team and the foresight necessary to perceive potential conflicts and establish mitigation measures. In the final month of SRA, CHAFEE completed Search and Rescue Certification (SAR), ISIC Light Off Assessment (LOA), Conventional Ordnance Safety Review (COSR), Aviation Certification (AVCERT), and Aviation Readiness Qualification (ARQ). COSR, normally a five day inspection, was completed in six hours. The ISIC Light-Off Assessment resulted in the sought "safe to operate" verification for the Engineering Department, and the Navigation Team attained certification in a near-perfect ISIC Navigation Check Ride. An outstanding Conventional Ordnance Safety Review inspection was concluded in November 2010, and a Command Readiness Assist Visit (CRAV) in December revealed a command strongly committed to supporting its Sailors.

Weekly Activity Report Points of interest:

- 1. Week Ending 05FEB10. CHAFEE successfully completed the MIDPAC Medical Readiness Inspection, earning an "outstanding" C-1 overall grade. Inspectors were impressed with the organization and preparedness of the medical department.
- 2. Week Ending 12FEB11. CHAFEE completed the MIDPAC Command Career Counselor review this week with a 100% grade. MIDPAC NCC presented the ship with the 2008 PACFLT Retention Excellence Award.

- 3. Week Ending 06JUN10. Completed a Theater Security Cooperation port visit to Malaysia. This visit included COMSERV project at an orphanage, senior leadership engagement, ship tours and a futsol (indoor soccer) match.
- 4. Week Ending 30JUL10. CHAFEE had an excellent RIMPAC experience. The level of tactical integration was high. Our ASTACs logged over 64 hours of control time; and more importantly the AICs controlled live DCA for three missions during the tactical phase.
- 5. Week Ending 17DEC10. NEY Assessment. CHAFEE provided an effective performance at the NEY evaluation. Also during this week the CRAV was completed and all programs were assessed as effective, with very minor discrepancies noted.

USS CHAFEE began 2010 in a continuous maintenance availability (CMAV). The major maintenance action was the refurbishment of the flight deck in preparation for an upcoming Western Pacific Deployment. Following completion of CMAV, CHAFEE was underway for USS LA JOLLA (SSN-701) post availability sea trials, providing on-scene support and safety. Upon return to homeport, the ship focused on completing required training events prior to deployment. These included the successful completion of Single Ship ASW team training, Naval Surface Fire Support team qualification and Advanced Air Warfare training provided by the Center for Surface Combat Systems. CHAFEE also conducted Week One Work-Ups with HSL-37 Detachment 1 (The Easy Riders). In the final weeks before deployment, CHAFEE embarked over 150 family members and friends for a one day cruise through the Hawaiian Operational Area and the waters off Waikiki.

CHAFEE departed for deployment in April 2010 and held the Change of Command ceremony 24 APR 2010 in Singapore. This was immediately followed by MALABAR 2010, an exercise to enhance bilateral ties and increase interoperability with Indian forces. While deployed, the ship successfully conducted Naval Surface Support (NSFS) FIREX II qualification on Oki-Daito Jima (ODJ) in the Western Pacific. At the time of qualification, CHAFEE was one of only two ships in the last seventeen attempts to successfully certify on ODJ. Immediately upon return from deployment, CHAFEE participated in Rim of the Pacific with the RONALD REAGAN Strike Group.

In August 2010, CHAFEE was selected as a CAPTAIN EDWARD F. NEY Award finalist and scored a 93.2% on Material Maintenance Management (3M) Certification, with no department receiving less than a 94.5%. CHAFEE also completed the OHSAT certification.

From August to December, CHAFEE underwent complex maintenance upgrades and installation of the SQQ-89A (V) 15 sonar suite and the MK38 Mod 2 25mm guns during a 15 week CNO Availability/ Selected Restricted Availability (SRA).

In the final month of SRA, CHAFEE completed Search and Rescue Certification (SAR), ISIC Light Off Assessment (LOA), Conventional Ordnance Safety Review (COSR), Aviation Certification (AVCERT), and Aviation Readiness Qualification (ARQ). COSR, normally a five day inspection, was completed in six hour

In December, CHAFEE satisfactorily completed a Command Readiness Assist Visit with Commander, Naval Surface Group Middle Pacific.
