During the 2011 Calendar Year, USS CHAFEE set to certify in all warfare areas in preparation for her upcoming 2011-2012 Western Pacific Deployment. While focusing on advancing operational effectiveness across the range of mission areas, the ship underwent several periods of extensive maintenance to repair and upgrade systems. Over the course of the calendar year, CHAFEE was called upon to provide support of the Chief of Naval Information's public affairs strategy of targeted communications.

CHAFEE embarked Naval Junior ROTC members to display and inspire aspiring young men and women to pursue commissions and lead the next generation of Sailors. CHAFEE's media appearances sought to display active U.S. Naval Ships conducting operations in the popular television series "The Deadliest Catch" and the movie "Battleship." Promoting domestic support for the U.S. military in general and for the Navy specifically, CHAFEE was selected to participate in the Los Angeles Navy Days and Seattle Seafair. CHAFEE crew proudly provided tours to over 3600 civilians during these two events.

CHAFEE deployed on November 29, fully certified as an independent deployer. On December 3, CHAFEE changed operational control to SEVENTH Fleet. CHAFEE supported SEVENTH Fleet's strategy to advance Asia-Pacific regional security and prosperity by employing credibly led, combat-ready forces in naval, joint and combined operations in support of U.S. Pacific Command.

CHAFEE displayed U.S. commitment to the region through several high profile operations. CHAFEE's Taiwan Strait Transit and South China Sea Operations demonstrated U.S. resolve to maintain presence and set normal operations routines within that region. CHAFEE distinguished herself by providing short notice escort for the CARL VINSON Strike Group during a high profile transit through the South China Sea, ensuring her safety and security enroute to FIFTH Fleet.

CHAFEE fully certified as an independent deployable unit during 2011 prior to deploying 2011NOV29. Enclosures (1) through (8) provide more detail for CHAFEE's warfighting training, certification, and operational mission accomplishment.

The road to this certification began in the first quarter. CHAFEE successfully completed Cruise Missile Tactical Qualification (CMTQ); certifying the strike team to employ all variants of the Tomahawk Land Attack Missile. The following week, CHAFEE's training teams completed Shipboard Team Trainer (SBTT) from the Afloat Training Group (ATG) so that they may be better equipped to lead onboard training scenarios for the crew.

ATG Limited Team Training (LTT) events were held to ramp up specific areas where high crew turnover had occurred or where the ship assessed a training need. CHAFEE's various training teams, along with trainers from ATG, assisted CHAFEE's watch teams during the Visit Board Search and Seizure, Anti-Terrorism Force Protection, Supply, Damage Control, Engineering Casualty Control, Seamanship, Link Response, and Electronic Navigation LTT's from February to April.

CHAFEE continued to work on individual and multi-ship warfare events during KOA KAI 11-2. This Destroyer Squadron THREE ONE led event consisted of warfare-focused serials and culminated of a final battle problem in and around the Hawaiian Island Operating Areas. The weeks of 10 and 18 April were particularly noteworthy for CHAFEE. Watch teams and training teams performed admirably, certifying for self-assessment during Unit Level Training Readiness Assessment-Engineering/ Certification.

CHAFEE proved Anti-Submarine Warfare (ASW) prowess through superior performance during Combat Systems Ship Qualification and Testing for CHAFEE's new SQQ-89A(V)15 sonar suite and Multi-Functional Towed Array (MFTA). During the testing, CHAFEE successfully fired ASW weapons via every means available. Additionally, CHAFEE provided superior training to the submarine forces acting as opposing forces during the Submarine Command Course Operations, the REAGAN Undersea Warfare Exercise, POMEVAL for Submarine Squadron ONE, and again during KOA KAI 12-1; enclosure (8) germane. CHAFEE's logistics operations were similarly successful. CHAFEE scored Excellent during Field Examination Group inspection and Outstanding during Supply Management Certification. Enclosure (4) refers and underscores how important logistics are to sustaining CHAFEE throughout her training, certification, and deployment preparations.

Through the year, CHAFEE successfully completed four continuous maintenance availability periods and a maintenance window of opportunity. Successful work and repairs were made on number one generator, both of CHAFEE's Rigid Hull Inflatable Boats and the freeze box coil from CHAFEE's reefers.

During these maintenance opportunities, CHAFEE worked with the local Pearl Harbor maintenance team to perform regular maintenance, repairs, assessments, and upgrades. Many of the upgrades were planned to make CHAFEE a more "Green" ship in accordance with the Secretary of the Navy's plan to reduce energy usage by making ships more efficient.

Enclosure (11) discusses CHAFEE's leading practices for Energy Conservation (ENCON) and those maintenance actions that specifically addressed this goal. The primary maintenance actions that lent themselves to ENCON were the Low Pressure air assessment, HVAC assessment, air conditioning plant groom, hull cleanings, electrical infrared assessment, and all associated repairs.

The LP air repairs saved 62,956 thousand cubic feet of lost LP air. The A/C Plant groom reduced average kW/Ton from 1.0989 to 0.8281 resulting in \$453/day inport savings and \$1,624/day underway in savings, or an annual savings of \$374K. Other repairs sought to enhance space and equipment temperatures and to ensure the ship's motion was unimpeded through the water, thereby reducing total energy costs.

Maintenance actions and repairs that fell outside upgrades for ENCON sought to prepare CHAFEE for long-term sustainability during forward deployed operations and were vital to final engineering and combat systems certifications.

CHAFEE provided enhanced support of Navy public relations throughout 2011. CHAFEE hosted Big Island, Hawaii, Navy Junior ROTC cadets in April, and twenty-six Tiger family members and friends of the crew in August. CHAFEE provided film location, support and interviews for the popular television show 'The Deadliest Catch' (June) and the movie 'Battleship' (November).

Mid-year, CHAFEE traveled to participate in Los Angeles Navy Days and Seattle Seafair, hosting over 3600 visitors to public affair tours onboard (Once CHAFEE deployed, the crew participated in several Community Relations events in Guam and Hong Kong, enhancing U.S. relations across the Pacific Rim).

On October 5, Commander Justin Kubu relieved Commander Chase Patrick as Commanding Officer at a ceremony conducted in Pearl Harbor. Commander Kubu is CHAFEE's first XO/CO Fleet Up. This Navy initiative allows more continuity in the leadership of a ship. Commander Kubu served as Executive Officer for 2 years and then assumed Command; his command tour is nominally for 18 months. In November, CHAFEE again participated in the Destroyer Squadron THREE ONE-led KOA KAI 12-1. This time, CHAFEE was fully certified and performed duties as Air Defense Commander during the intermediate phase of training. CHAFEE performed well across all warfare areas and received accolades for ASW and AAW performance.

CHAFEE deployed on November 29, fully certified as an independent deployer. On December 3, CHAFEE changed operational control to Commander Destroyer Squadron FIFTEEN, Commander Task Force 70, SEVENTH Fleet.

CHAFEE supported SEVENTH Fleet's strategy to advance Asia-Pacific regional security and prosperity by employing credibly led, combat-ready forces in naval, joint and combined operations in support of U.S. Pacific Command.

CHAFEE displayed U.S. commitment to the region through several high profile operations. CHAFEE's Taiwan Strait Transit and South China Sea Operations demonstrated U.S. resolve to maintain presence and set normal operations routines within that region. Assigned to the Theater ASW mission, CHAFEE successfully searched for, located, and supported other theater assets in tracking a SEVENTH Fleet high priority target.

CHAFEE distinguished herself by providing short notice escort for the CARL VINSON Strike Group during a high profile transit through the South China Sea, ensuring safety and security enroute to FIFTH Fleet.

In reflection, CHAFEE successfully completed all assigned missions, whether training, maintenance, strategic communications, or operational tasking in a safe manner; enclosures (9) and (10) speak to CHAFEE's superior record of Safety. CHAFEE completes the 2011 calendar year in a forward deployed status.
