COMMAND COMPOSITION AND ORGANIZATION

- 1. Mission. USS CROMMELIN's mission is to provide air, surface and undersea protection for underway replenishment groups, convoys, amphibious forces and other military and merchant shipping. In addition, CROMMELIN was principally employed at the Maritime Interception Operations (MIO) mission while deployed in the FIFTH Fleet area of responsibility (AOR) from September 2000 to January 2001.

NARRATIVE

CROMMELIN completed a demanding year of maintenance, training, and real world operations in 2000. In February and March, CROMMELIN spent six weeks transiting to the Southern California operating areas to participate in the Composite Unit Exercise (COMPTUEX) with the ABRAHAM LINCOLN Battle Group (ALBG). In late May, CROMMELIN rejoined the ALBG for a four-day anti-submarine warfare exercise in the Hawaiian operating areas over the Memorial Day Weekend, followed a week later with participation in the multinational Rim of the Pacific (RIMPAC) exercise. CROMMELIN capped the year with a record-breaking deployment to the Western Pacific Ocean and Arabian Gulf.

CROMMELIN spent the year-2000 as an integral member of the ABRAHAM LINCOLN Battle Group. The ALBG consisted of the following units: USS ABRAHAM LINCOLN (CVN 72), USS SHILOH (CG 67), USS BUNKER HILL (CG 52), USS CAMDEN (AOE 2), USS FLETCHER (DD 992), USS PAUL HAMILTON (DDG 60), USS TUSCON (SSN 770), and USS CHEYENNE (SSN 773), and Carrier Air Wing FOURTEEN. ALBG was led by Commander, Cruiser-Destroyer Group THREE under the command of Rear Admiral Phil Balisle and Commander, Destroyer Squadron THIRTY-ONE commanded by Commodore Pete Daly. COMPTUEX and RIMPAC/FLEETEX events highlighted the first half of the year as the battle group "worked up" for their scheduled overseas deployment. Exercises included extensive training in all intermediate warfare mission areas with emphasis on battle group cohesion. In these exercises, CROMMELIN excelled in Air Defense Coordination (ADC), Under Sea Warfare (USW), Surface Warfare (SUW), Strike Warfare (STW), and Maritime Intercept Operations (MIO) exercises earning the sobriquet "Pocket Cruiser" from Admiral Balisle. During the return transit from the eastern Pacific to Pearl Harbor in February, CROMMELIN learned she had been awarded the coveted Destroyer Squadron 31 Battle Efficiency Award for 1999.

On June 2, 2000, CROMMELIN conducted a change of command ceremony as Commander Alan C. Westphal relieved Commander Craig S. Kleint.

RIMPAC 2000 followed mere days later, giving Commander Westphal his first opportunity to lead the CROMMELIN in a tactical setting. The huge multi-national exercise included ships and aircraft from navies of Australia,

Canada, Japan, Korea, and Chile in addition to many San Diego-based ships. The extensive exercises tested all facets of naval warfare and provided an excellent training opportunity for the crew. The lessons learned would soon be put to the test during the ALBG's overseas deployment.

RIMPAC was followed by eight weeks of leave and liberty for many of the crew along with aggressive preparations for the scheduled overseas deployment. Most noteworthy among these preparations was the replacement of 1A Gas Turbine Engine with a newly rebuilt unit. Indeed, throughout the year, CROMMELIN's crew distinguished themselves by their sense of ownership and industry in pursuit of material maintenance and repair. In recognition of their exceptional effectiveness at maintaining the ship with minimal support from the shore-based technical and repair establishment, CROMMELIN was awarded the Naval Surface Force, Pacific Self-Sufficient Ship of the Quarter award for the first and fourth quarters. In an addition, CROMMELIN was nominated by CINCPACFLT for the Secretary of Defense Maintenance Award for 2000.

Deployment began with another remarkably successful anti-submarine warfare exercise pitting the ALBG against a U.S. Navy SSBN that was returning from her own deployment via the Hawaiian area. Under COMDESRON 31's able direction, the ALBG succeeding not only in avoiding detection and attack, but in conducting multiple simulated attacks against the opposing submarine.

The auspicious beginning of the deployment proved to belie the typically reactive environment that would follow CROMMELIN and the ALBG for most of the balance of the deployment. The subsequent highlights of the cruise through the SEVENTH Fleet AOR included a lengthy diversion from planned track to avoid a major storm, Typhoon Saomai in the Western Pacific. The storm evasion resulted in the ship missing a planned port visit in Hong Kong. was made up for with visit to Singapore. Even that opportunity proved short lived as world events necessitated the rapid arrival of the ALBG in the FIFTH Fleet. CROMMELIN conducted and emergency sortie from Singapore on 17 September and joined the battle group in a flank bell transit from the Malacca Strait to Bahrain. average speed of 25 knots, this single-screw frigate distinguished herself and her engineers by keeping pace

with a nuclear-powered aircraft carrier throughout the transit.

Following a four-day stop in Bahrain for FIFTH Fleet arrival briefings, CROMMELIN proceeded to the Northern Arabian Gulf, a span of brown shallow water, replete with wrecks, oil wells, terminals, and countless surface contacts that would become CROMMELIN's hunting grounds for the next 100 days. Operating in the northernmost reaches of the Arabian Gulf deep inside Iraqi territorial waters and in very close proximity to Iran, CROMMELIN typically operated with her SH-60B LAMPS helicopter detachment (Det 3) from HSL-37 out of Kaneohe Bay, Hawaii, unassisted and unsupported by any other U.S. or Allied forces. to the maritime intercept operations (MIO) mission, CROMMELIN pursued and seized smugglers of Iragi oil in support of United Nations resolutions controlling the export of petroleum from Iraq. During this period of time, CROMMELIN was likely on any given day, literally to be the most forward-deployed ship of the U.S. Navy. Despite the extreme physical and psychological hostility of the environment, CROMMELIN would excel at her MIO mission, shattering the single-ship record for seizures of oil smugglers with a total of eighteen non-compliant boardings resulting in twelve ship seizures. The CROMMELIN boat crew and Boarding Team demonstrated extraordinary discipline and physical courage in their tasks, returning unscathed and successful from virtually every mission. These personnel would be recognized personally at the end of the deployment by a special visit to the ship by Admiral Balisle to award each of the Navy Achievement Medal.

As hostile as the environment seemed at the onset of the MIO mission in the NAG, the stakes were raised immensely with two incidents in mid-October. On 12 October, CROMMELIN arrived in Doha, Qatar for a planned port visit and bi-national exercise with the Qatar Navy. The visit was terminated after only three hours by the horrific news of the terrorist bombing of USS COLE in Aden, Yemen which resulted in orders from FIFTH Fleet for all ships to get underway immediately. This emergency sortie, the second of the deployment for CROMMELIN, would be the last opportunity to touch shore for the CROMMELIN crew for 62 days. The second incident occurred the following day. On the 13th, back on station in the NAG, CROMMELIN was ordered to conduct a boarding of a vessel attempting to enter Iraqi waters without authorization. As the ship's

boat approached the suspect vessel, the vessel turned and ran for the security of nearby Iranian territorial waters. As the boat turned to return to CROMMELIN, observers on CROMMELIN's bridgewing observed two heavily armed ASHURAclass patrol boats of the Iranian Republican Guard Navy (IRGCN) pursuing the slower, RHIB. As CROMMELIN maneuvered at full speed to approach and neutralize the situation, the ASHURAs closed within a few yards of the RHIB, brandishing weapons, including at least one heavy machine gun, and signaling for the RHIB to stop. The boat crew and Boarding Team responded with remarkable courage in the face of what may have been a life-and-death situation. They kept the RHIB at maximum speed and continued to attempt to close the ship. Minutes later, as the RHIB and her pursuers and CROMMELIN converged within a few hundred yards, the Iranians' discretion got the better part of their valor, and they turned to withdraw from the scene. CROMMELIN recovered her RHIB and personnel with no further incident. This incident on the heels of the COLE bombing served to highlight the serious nature of the MIO mission in the Northern Arabian Gulf. In the aftermath, the crew resolved to apply lessons learned from these force protection experiences and never to be taken at disadvantage. resolve was manifested in a steel-eyed determination to be the best ever at the MIO mission.

While in the Northern Arabian Gulf, the veteran Visit Board, Search, and Seizure (VBSS) team participated in eighteen non-compliant boardings of suspected sanctions violators. Among the eighteen non-compliant vessels, twelve were found to be smuggling petroleum products from Iraq and diverted to friendly ports for disposal of the ships and their illegal cargo. Additional details of these boardings and seizures are provided in the Chronology (enclosure 2). One aspect of the MIO environment during CROMMELIN's term in the Gulf warrants amplification. is the effect of CROMMELIN's aggressiveness and success on the tactics and methods employed by the smugglers. CROMMELIN's 3.5 months in the FIFTH Fleet, and as CROMMELIN effected seizure after seizure, it became apparent that smugglers were resorting more and more to group sailings and payoffs (bribes) to Iranian authorities to enable them to transit to market unmolested by MIO forces. Most dramatic was the greatly increased frequency of installing protective devices, notably steel plate welded over accesses and various trip hazards and high-voltage electrical traps to deter boarding teams. Despite these

counter-measures, CROMMELIN was similarly able to adapt tactics, notably with the use of portable oxygen-acetylene cutting equipment to burn openings in steel deckhouses to gain access and seize control of the smuggling vessels. Seizures of these "armored Tankers" required more time to effect than unprotected vessels. With the memory of the ASHURA incident always in mind, Commander Westphal always maneuvered CROMMELIN to remain close-aboard the suspect vessels to provide direct support to the Boarding Team while they did their work. This led to some extremely exciting moments among the CROMMELIN Bridge and Navigation team, as well as some extraordinary and highly unconventional shiphandling among CROMMELIN's conning officers among densely crowded shipping lanes, anchorages, and shallow water regions! Despite the hazards to all involved, the tactics proved effective, and CROMMELIN was able to take credit for the seizures of four of these "armored tankers" among her twelve seizures.

In an effort to promote cooperation with our Arabian Gulf allies, CROMMELIN conducted combined operations with the Kuwaiti Coast Guard and Navy on two occasions. It was readily evident that a firm resolve went into enforcing the sanctions against their much-hated neighbor, and CROMMELIN was privileged to observe the Kuwait Coast Guard effect at least seven seizures of Iraqi smugglers.

The 31st of December 2000 found CROMMELIN and the ALBG handing off the security of the FIFTH Fleet AOR to the HARRY S TRUMAN Battle Group and transiting outbound through the Strait of Hormuz. This was the conclusion of a banner year for CROMMELIN and her crew. The weeks ahead would bring well-earned rest and relaxation with port visits in Darwin; Cairns; and Brisbane, Australia, followed by a brief stop in Samoa and a glorious homecoming to Pearl Harbor. On the eve of the homecoming from deployment, CROMMELIN would be informed of her second consecutive award of the Battle Efficiency Award for the year-2000.
