USS DECATUR (DDG-73) COMMANDER'S ASSESSMENT

DECATUR maintained operational focus and continued its history of success through a busy and challenging year of 2011. The year started with the conclusion of a WESPAC deployment, major exercise participation, public affairs participation and an assessment, certification and training cycle. Sailors in all warfare areas worked hard to contribute to DECATUR's overall success and superior performance in assessments, inspections and operations.

DECATUR's crew embraced and excelled at all challenges during the 2010/2011 Western Pacific Deployment that span from 21 Sep 2010 to 21 Apr 2011, her third in three years. As part of this deployment, DECATUR spent the first two months of 2011 on station in FIFTH Fleet. Her assignments during this time included defending key Iraqi commercial infrastructure, performing critical National Taskings and participating in numerous Theater Joint Air and Ballistic Missile Defense (BMD) exercises.

DECATUR not only participated in, but led the way in several exercises during deployment in the FFITH Fleet Area of Responsibility. While operating in FIFTH Fleet, DECATUR took part in seven USCENTCOM Theater Ballistic Missile Defense Exercises. Additionally, while on deployment DECATUR'S Strike Team performed flawlessly through four MIDNIGHT EXPRESS Exercises and 11 PERSIAN TEMPEST events. After returning from deployment, DECATUR sailed north to the Alaskan Coast in June in order to participate in Joint Exercise NORTHERN EDGE. During this exercise, DECATUR worked closely with Navy and Air Force airborne assets to prepare forces for contingency response in Asia-Pacific region. Through all major exercises, DECATUR

demonstrated outstanding proficiency and the ability to meet tasking.

Throughout WESTPAC 2011, DECATUR participated in community relations events, including multiple events during a high-priority SEVENTH Fleet Security Cooperation Visit to Chennai, India in March. DECATUR hosted the Commodore of Tamil Nadu Naval Region, the Consul General of Chennai and other local and other regional government officials during a VIP reception. As a part of the U.S. Consulate's celebration of Women's History Month, the Commanding Officer and a group of Sailors, Chiefs and Officers participated in a live-streamed panel-style discussion for 100 local students. Additionally, while in India, members of the crew participated in events including a visit to the Academy of Maritime Education and Training and interacted with special needs children during a visit to Vidya Sagar School.

DECATUR returned from deployment and maintained high levels of proficiency across all warfare areas through aggressive scheduling and accomplishment of maintenance and training. In August, DECAUR started a scheduled \$7.3 million CNO Selected Restricted Availability (SRA). Even while in a shipyard maintenance period, DECATUR continued to build on previous successes by scoring highly at the rigorous Single Ship ASW course, a performance which earned a "Bravo Zulu" from course instructors. Upon completion of the SRA period, DECATUR's Engineers welcomed Engineering Assessments Pacific (EAP) abroad for Light Off Assessment (MOB-E 1.1A) in November. identified 137 restrictive items in their assessment and of those the Engineers immediately cleared 131, satisfactorily demonstrating 92.2% of all cold checks. In their final report, EAP recognized the difficulties of SRA as well as the professionalism of the department; noting "The Chief Engineer

and his team were fully engaged and able to overcome obstacles related to the timely space turnover early in the assessment. Later in the month, EAP again came aboard and rated DECATUR as "outstanding" in the follow-on MOB-E 1.1B assessment.

In summation, DECATUR continued to set the standard for success during this busy and difficult year. Whether it was deployment, assessments or high profile events, DECATUR's Sailors were always ready to respond with the skill and professionalism that is their hallmark. I am proud of our accomplishments during 2011. I have no doubt that DECATUR will continue her excellence into 2012 and beyond.

USS DECATUR (DDG-73) CHRONOLOGY NARATIVE

DECATUR began 2011 on station in FIFTH Fleet attached to Commander Task Force 153 conducting a variety of missions. In January and February, the DECATUR Strike Team was designated as the exclusive Central Arabian Gulf Tomahawk Back-up Shooter and the Alternate Launch Area coordinator. The Strike team performed flawlessly through four MIDNIGHT EXPRESS Exercises, 11 PERSIAN TEMPEST events and two SHAMAL exercises. Additionally DECATUR conducted over 25 Approach and Assist Visits, providing valuable intelligence to Task Force 152 Commanders. In February, DECATUR participated in Operation NEW DAWN, defending key Iraqi commercial infrastructure. In the beginning of March, the ship transited the Strait of Hormuz and chopped into SEVENTH Fleet on 12 March.

In the middle of March, DECATUR stopped in Chennai, India as part of a high-priority SEVENTH Fleet Security Cooperation Visit during which DECATUR hosted the Commodore of Tamil Nadu Naval Region, the Consul General of Chennai and other local and regional government officials during a VIP reception. As part of the U.S. Consulate's celebration of Women's History Month, the Commanding Officer and a group of Sailors, Chiefs and Officers participated in a live-streamed style panel discussion for 100 local students. Additionally, while in India, members of the crew participated in events including a visit to the Academy of Maritime Education and Training and interacted with special needs children during a visit to Vidya Sagar School.

DECATUR chopped to THIRD Fleet in the first week of April, finally returning home, after months deployed. After some well deserved POM leave, DECATUR was back at sea. In June, she participated in Joint Exercise NORTHERN EDGE off the coast of Alaska. During this event, DECATUR worked closely with Navy and Air Force airborne assets to exercise contingency response in the Asia-Pacific region.

In late July, DECATUR offloaded her ammunition from deployment in Seal Beach, CA before entering into the Continental Maritime San Diego Shipyards for a Selective Restrictive Availability Period in August. Immediately after entering the shipyards, the DECATUR Anti-Submarine Warfare (ASW) Team completed the Single Ship ASW Course, scoring an impressive 88%.

In October, DECATUR successfully completed her Mobility Damage Control Assessment (MOB-D) 1.1, Mobility

Navigation Assessment 1.1 and 1.2, Mobility Seamanship Assessment 1.1 and 1.2, as well as her Aegis Weapons Training Phase I Auxiliary Ship's Assessment Group Training.

Upon completion of the SRA period, DECATUR's Engineers welcomed Engineering Assessments Pacific (EAP) aboard for Light-Off Assessment (MOB-E 1.1A) in November. EAP identified 137 restrictive items in their assessment and of those the Engineers immediately cleared 131, satisfactorily demonstrating 92.2% of all cold checks. In the third week in November, DECATUR left the CMSD Shipyards for Sea Trials. During Sea Trials, the ship passed MOB-N 1.3. At the end of the month, EAP again came aboard and evaluated DECATUR as "outstanding" in the follow-on MOB-E 1.1B assessment.

In December, the ship got underway for the final time in 2011. During this underway, DECATUR completed MOB-E 1.3 and MOB-S 1.3 Assessments as well as participated in Aviation Helo Day, certifying her flight deck for helicopter operations.

DECATUR closed out 2011 enjoying Holiday Standdown leave and looking forward to the challenges that will lie ahead in 2012.
