b. Command organization and relation

(1) The USS DUBUQUE (LPD-8) served as a unit of the Amphibious SQUADRON ONE. The following officers commanded the ship

and execute an amphibious operation involving embarkation, transit to an objective area and an aggault of the objective under combat conditions, employing the latest and most effective amphibious force doctrine.

3. (C) <u>Operations</u>.

LOTAL January 1969 COMPHIBRON ONE, CAPT. W. D. OWEN, USN, was embarked in USS DUBUQUE. On 21 and 22 January COMPHIBRON ONE held an administrative inspection and graded DUBUQUE as high good two points below excellent.

On 29 January COMPHIBRON ONE shifted his pennant to Building 29, U. S. Naval Base, Coronado, California. On 30 January the DUBUQUE entered into a yard overhaul at Long Beach Naval Shipyard. This period extended until 9 April.

On 16 February as a part of the Policy of the chaplain of inviting civilian church groups to attend divine services aboard, and to tour the ship, 100 members of the Long Beach Philadelphian Seventh-day Adventists church and the Westminister Church of the same denomination were guests of the DUBUQUE. This being race relations Sunday, the black pastor of the Philadelphian Church was invited to share in conducting the service. The results were increasing friendships between the two congregations and between the civilians and the Navy. A two hour tour was laid on for the guests by LCDR GOODWIN.

On 20 February COMPHIBRON ONE **å**ttended the change of command ceremony as CAPT P. J. HARTLEY, USN, relieved CAPT H. J. URSETTIE, USN, as Commanding Officer of USS DUBUQUE.

On 9 April DUBUQUE returned to San Diego. On 14 April DUBUQUE commenced local operations to work up after her yard period.

On 15 May 75 members of the Department of Defense Sponsored joint civilian orientation conference 39 embarked for demonstrations. DUBUQUE proceeded to an anchorage 161 Coronado Roads where helocopter and boatt operations were laid on. In addition to that which DUBUQUE did for the J COC guests, pararescue and SGAL teams put on demonstrations which were observed by the guests from the flight deck off DUBUQUE.

20-28 May were spent in a rigorous refresher training period as the new DUBUQUE sailors demonstrated th**at they had been** welded into an efficient unit with those seamen who had remained from the previous deployment.

29 May - 12 June was just as heavy a period as the ship underwent amphibious refresher training. This culminated in COMPHIBRON ONE CAPT J. E. MCCAULEY, USN, embarking on 13 June along with 600 Combat equipped Marines from Camp Pendleton. DUBUQUE with other units of the squadron participated in exercise Bell Call. This terminated 21 June.

On 21 July 420 U. S. Naval Academy Midshipmen embarked for their summer cruise. 22 July COMPHIBRON ONE transferred his pennant to USS NEW ORLEANS. On 26 July 8 guests of the secretary of the Navy embarked. The

Purpose for having these guests embarked is to provide representative citizens with an opportunity for first hand observations of Naval operations at sea. The ship's chaplain kept a full schedule of activities for the guests. One unscheduled activity occurred when a Petty Officer died at sea and a memorial service was laid on. In addition to the officers and men of the DUBUQUE, the embarked midshipmen and guests paid their respects to the deceased. The SECNAV guests departed DUBUQUE at Seattle 31 July after expressing their gratitude for the enlightening cruise.

The stay at Seattle 31 Jult - 5 August was a very full one. Involved were an enlisted dance at the military branch YMCA; Fleet Officer's Reception and ball at the Washington Athletic Club; and Midshipmen's ball at the Seattle center on 31 July. On 1 August general visiting was held on ship. The general mess hosted 5 Sea Fair Princesses. A Navy League Reception for the CO/XO/LCDR was held in Seattle. A military ball for enlisted men sponsored by USO was held at the Olympic Room, Seattle Center. On 2 August general visiting aboard, and ashore a YMCA dance for enlisted men. On 3 August the general public were invited to divine services. The Junior Choir from "Christ The King" interdenominational school provided the music. 86 members of the Puyallup Seventh-day Adventist made the 70 mile round trip to attend and to tour the ship. General visiting was held in the afternoon and another enlisted dance was held in the afternoon and another enlisted dance was held at the YMCA.

On 1 August due to the Westpac deployment of: PHIBRON ONE, the DUBUQUE was assigned to PHIBRON FIVE for administrative purposes. On 5 August DUBUQUE departed for Pearl Harbour and held extensive training for embarked midshipmen enroute.

16-21 August DUBUQUE enjoyed the stay at Pearl Harbour. While the welcome and hospitality were not as overwhelming as that at Seattle, the officers and crew enjoyed the opportunity to tour this very attractive island.

On 21 August the ship departed for San Diego arriving in the area on the 28th. On 29 August embarked midshipmen observed as DUBUQUE underwent an operational readiness inspection by COMPHIBRON FIVE.

During September DUBUQUE remained at San Diego as final preparation were made for the Westpac deployment. On 25 September the 2nd Annual ship's party was held in the ballroom of a major hotel in San Diego and was a great success.

On 1 October DUBUQUE deployed to Westpac going direct to Danang and arriving on 19 October. DUBUQUE proceeded to Cua Viet on 21 October and embarked troops of the 3rd Marine Division in a KEYSTONE CARDINAL lift to Kin Red Beach at Okinawa, arriving there 25 October.

On 30 October DUBUQUE was back at Danang for a boat lift to Subic arriving 1 November. After a short stay DUBUQUE departed for Cua Viet to

spent loading. Lift was discharged at Buckner Bay 12 November. 5-9 November was departed for Subic Bay 14 November.

On 18 November RADM E. W. ROSENBERG COMPHIBGRU ONE CTF 76 and TACRON 12 embarked. 20 November DUBUQUE departed for Cua Viet for 3rd KEYSTONE CARDINAL lift departing Cua Viet on 24 November. On 28 November KEYSTONE CARDINAL lift disembarked at Buckner Bay. On 29 November DUBUQUE departed for Danang to lift fuel barge to Vung Tau stopping at Cam Rahn Bay for a R & R stop enroute.

On 6 December DUBUQUE arrived Buckner Bay, Okinawa. On 22 December RADM E. W. ROSENBERG COMPHIBGRU THREE and TACRON 12 were relieved by C COMPHIBGRU THREE, RADM V. DYBDAHLS and TACRON 13 aboard USS DUBUQUE.

On 23 December DUBUQUE departed for Danang, Vung Tau and An Thoi where she was anchored 31 December.

4. (C) Special topics

a. Communications

Throughout the deployment, training in all areas of communications was emphasized.

Communications consisted of the multi-channel broadcast, a full-period, 4 channel termination with ship/shore backup and numerous voice circiuts including multi-channel ship/shore relay when operating off Danang. Much of the tediousness of routine was simplified by the introduction of STROFAG into the ship/shore communications facilities. In February, DUBUQUE, being a subscriber to STROFAC by virtue of having COMPHIBGRU ONE aboard was required to copy only channel 5 of the multi-channel broadcast until the staff departed.

The Westpac traffic load without the staff averaged about 30 messages a day, jumping to about 500 messages per day with the staff aboard. Thus it is readily apparent that the main battery of DUBUQUE during the staff's reign became communications - communications then becoming about 50% of DUBUQUE's workload as apposed to its normal 15% in Westpac.

Most notable of DUBUQUE's communication experience in Westpac was the utilization of TH-39's to effect a 4 channel termination since the P system was neither installed nor available at the time. It is believed that a much more reliable termination could have been effected by use of the P system and it is highly recommended that the P system be installed on any ship in preparation for carrying the Amphibious Force Seventh Fleet Staff.

b. Chaplain's activities

In addition to regular services held by the chaplain for the Protestant personnel, he arranged for Catholic coverage. Lay leader Services for Catholics by LT Control SC, USN, and for Jewish personnel by LT Control MC, USNR. During the midshipmen cruise Chaplain of the USS POINT DEFIANCE and DUBUQUE's chaplain exchanged ships twice for one week each time in order to provide full Catholic and Protestant coverage. Liason was maintained with civilian churches and missionaries both in CONUS and overseas. Books donated by the Oceanside Seventh-day Adventist church in California were presented to an elementary school in Olongapo, R. P.

(c) Community relations

The JCOC demonstration listed in the basic narative, and the SECNAV guest cruise to Seattle were the outstanding examples of community contacts. In addition the tours conducted on Sunday following divine services created good will in Long Beach and San Diego.


g. Medical

This data indicates that the 1969-1970 Westpac cruise was a busy period for "H" Division. In addition to the routine functions provided by the Medical Department, we were called upon on numerous occasions to administer definitive emergency care. The most notable of the occasions was an emergency appendectomy accomplished at sea. This was the first time that DUBUQUE's medical team had utilized the operating room for major surgery.

h. Supply

1969 was a big year for the Supply Department. Disbursing paid out \$1,300,828.00 to DUBUQUE's crew. Ships store had sales of \$115,335.00. Food service fed 177,370 people. The storekeepers prepared 4413 requisitions for a total of \$139,610. The Westpac deployment went quite well with three highly successful "unreps" by helecopters.
