14 JAN ORI terminated by fire/explosions on flight deck. 27 dead, 62 hospitalized. CINCPACFLT inspected fire damage.

14 JAN - 4 MAR Inport Pearl Harbor.

15 JAN Preliminary investigation of 14 JAN incident by COMCARDIV ONE.

16 JAN SAR terminated. COMCARDIV SEVEN on board as Senior Member Formal Investigating Board.

11 FEB Formal Investigating Board completed investigation.

27 FEB ENTERPRISE presented with plaque commemorating relations between ship and shipyard during repairs.

3-4 MAR CINCPACFLT pre-deployment briefings.

3 MAR Conducted fast cruise.

5-10 MAR Hawaiian area operations and refresher training.

11 MAR Underway for WESTPAC.

13 MAR Crossed International Date Line.

22-26 MAR Philippine area operations.

27-28 MAR Inport Subic Bay. Pre-SPECOPS briefings by various WESTPAC activities. Embarked COMCARDIV ONE.

31 MAR - 16 APR SPECOPS Yankee Station.

27 JUN Crossed International Date Line.

2-13 JUL Inport Alameda.

8 JUL Change of Command. CAPT K. L. LEE, USN, relieved by CAPT F. S. PETERSEN, USN.

14 JUL Underway for Norfolk.

18 JUL Crossed equator. Initiated 2,380 new Shellbacks.

24 JUL Rounded Cape Horn.

29 JUL - 2 AUG Inport Rio de Janeiro.

12 AUG - 10 OCT Inport Norfolk Naval Shipyard.

12 AUG Commenced overhaul.

22 AUG

Moved to Dry Dock #8, NNSY.

11 OCT

Deadplant transit from NNSY to Newport News Shipbuilding and Drydocking Company, Newport News, Virginia.
