2. Commander's Assessment

2010 Commander's Assessment

The highlight of 2010 undoubtedly was USS HALSEY commencing her second deployment, and first as a member of a Carrier-Strike Group. Maintaining high productivity following the Board of Inspection and Survey (INSURV) at the end of 2009, HALSEY began the new year with some much deserved recharge time. Following a holiday leave period, HALSEY's crew began preparation for Unit Level Training and Readiness Assessment Sustainment (ULTRA-S); a training and readiness assessment to validate mid-cycle proficiency of HALSEY's twenty-three warfare areas. Scoring above average in all tested subjects, the crew shifted to practicing joint operations as deployment neared.

Underway in Southern California for single ship operations in February and March during preparations for ULTRA-S, HALSEY participated in Operation GREEN FLASH which included multi-agency operations to disrupt, dismantle, and defeat drug trafficking organizations and alien smuggling activities within the Southern California region. HALSEY coordination with Customs Border Protection and associated agencies resulted in the apprehension of twenty-two illegal Aliens off the coast of California - all amidst basic phase training events – exposing a smuggling network.

In April HALSEY transited to Seal Beach, CA to onload weapons for her upcoming deployment. She continued north to for a port visit in Esquimalt, British Columbia and the surrounding provincial capitol of Victoria. During her time in Canada, HALSEY crewmembers volunteered to clean up and restore a community center. Our Helicopter Squadron (HSM-77) detachment named 'Saberhawks' embarked HALSEY with two MH-60R helicopters for the first time during this operation and joined the family.

Following the Esquimalt, Canada, port visit, HALSEY rendezvoused with the USS ABRAHAM LINCOLN Strike Group (ALSG) for a three week-long Group Sail in the Southern California OPAREAS that concluded in May. ALSG was comprised of USS ABRAHAM LINCOLN (CVN 72), USS CAPE SAINT GEORGE (CG 71), USS MOMSEN (DDG 92), USS SHOUP (DDG 86), and HALSEY. During the Group Sail, ALSG ships practiced coordinated Air Defense (AD), Anti-Submarine Warfare (ASW) operations, Naval Surface Fire Support (NSFS), Visit, Board, Search, and Seizure (VBSS) events, and communications exercises in preparation for deployment.

As summer began, numerous workshops, schools, and pierside synthetic training exercises were conducted in order to hone the crew's skills for deployment. ALSG ships set sail in July for Composite Training Unit Exercise (COMPTUEX) which validated final preparations before HALSEY departed for deployment from Naval Base San Diego on September 11, 2010.

Speeding to SEVENTH Fleet, HALSEY arrived in The Republic of the Philippines in time to participate in Cooperation Afloat Readiness and Training (CARAT) 2010. In support of CARAT, HALSEY embarked Destroyer Squadron Thirty-one and hosted multiple coalition social events and warfare-based trainings and conferences. Departing the Philippines early due to a typhoon, HALSEY diverted south to Kota Kinabalu, Malaysia.

HALSEY engaged in numerous SEVENTH Fleet missions following Malaysia, including a strategic transit of the contested Spratley Islands and Joint Task Force Presidential Support operations for President Obama's first visit to Indonesia. On November 15th, HALSEY moored in Singapore where her crew executed "liberty as a mission." Upon her departure, HALSEY transited the Straits of Malacca enroute to the FIFTH Fleet Area of Operations.

Once in the Northern Arabian Sea, HALSEY provided Sectored Air Defense for the USS ABRAHAM LINCOLN and over 6000 coalition sorties in support of Operations ENDURING FREEDOM and NEW DAWN. HALSEY also led joint operations with French Aircraft Carrier CHARLES DEGAULLE and the French Frigate FORBIN. Several Sailors had the opportunity to visit the French ships, and HALSEY hosted several French Sailors.

After nearly 40 days at sea, HALSEY transited the Straits of Hormuz for a port visit to Bahrain, where she and her crew celebrated the arrival of 2011.

Throughout the year, HALSEY maintained an outstanding record of superb operational performance, reliable engineering readiness, a flawless safety record, and unmatched crew morale and esprit de corps that served as the foundation for every success. HALSEY concluded 2010 fully eligible for the Battle "E" and all Command Excellence awards.
