JANUARY

Air Department made 90 elevator runs with zero aircraft moves. Landing area non-skid maintenance was completed. V-3 moved three aircraft.

Combat Systems Department upgraded the GCCS-M 3.1.2.1 software and installed the Air Wing server rack.

Safety Department conducted a safety stand down.

Training Department checked in more than 150 new Sailors to the command

Public Affairs coordinated in-port tours for more than 300 visitors, including ADM Fallon, CFFC.

FEBRUARY

Air Department made 92 elevator runs, moving 301 aircraft. There were 997 launches and 997 recoveries. V-3 moved 20 aircraft in the hangar bay. V-4 issued 336,951 gallons of JP-5 to 457 aircraft and received 425,835 gallons of JP-5.

Combat Systems Department conducted TIP Operational Testing and began Integrated Shipboard Network System server upgrades.

Medical Department received a C-1 rating from Commander, Naval Air Forces, Pacific for the Medical Readiness inspection. They also received a C-1 rating for the Birth Month Medical Surveillance Inspection.

Safety Department conducted a Drunk Driving Awareness Safety Stand down.

Public Affairs coordinated in-port tours for more than 300 visitors. While underway, 72 distinguished visitors COD'ed out and received in-depth tours of the ship.

Weapons Department unloaded more than 130,000 pounds of ordnance.

MARCH

Administration Department became the first West Coast carrier to have the DEERS/RAPIDS Mobile CAC ID card system installed. Admin's Educational Service Office conducted 152 first class exams; 29, or 19.1 percent advanced; 648 second class exams; 82, or 12.7 percent advanced; 495 third class exams; 177, or 35.8 percent advanced.

Air Department made 292 elevator runs, moving 559 aircraft. V-2 made 987 launches and recovered 1037 aircraft. V-3 moved 190 aircraft in the hangar bay. V-4 issued 1,143,745 gallons of JP-5 to 1,053 aircraft and received 1,528,928 gallons of JP-5.

Engineering Department corrected 350 trouble calls ship-wide this quarter. They also fit-tested 4,2000 personnel for MCU-2P gas masks.

Medical Department received the Blue "M" Award from Commander, Naval Air Forces, Pacific for effective and efficient medical program management.

Public Affairs coordinated in-port tours for more than 600 visitors. While underway, 62 distinguished visitors COD'ed out and received in-depth

tours of the ship, including Major Gen. Simon Willis, Royal Australian Army.

Safety Department conducted a safety focus and No Fly Day.

Supply Department received the 2003 CNAP Disbursing Excellence Award, the 2003 CNAP Retail Sales and Services Excellence Award, the 2004 "Best in Class" for Retail and Services operations and the 2004 Dorie P. Miller Award for exceptional Private Mess operations. Supply also completed extensive renovations of the Chief Petty Officer's Mess.

Weapons Department unloaded 1,600,000 pounds of ordnance and expended 10,500 rounds of 9mm and 3,497 rounds of M-16 rounds for small arms training and qualification.

APRIL

Air Department's V-1 division made 335 elevator runs and moved 900 aircraft. V-2 launched 626 aircraft, recovering 572. V-3 moved 136 aircraft in the hangar bay. V-4 issued 766,813 gallons of JP-5 to 811 aircraft; 838,337 gallons were unloaded.

Combat System Department's CS1 division conducted an ACMI/VTC install for Northern Edge 2004 and hosted a group of EHF engineers and strategists from Military Satellite Operations Center in Schriever AFB, Colo. CS3 installed 96 LAN drop boxes. CS6 installed 1832 slave RADAR display near CO's chair, repaired bad SPS-67 and SPS-49 video in Zulu mod SPA-25G,

Public Affairs coordinated in-port tours for more than 800 visitors, including the Department of Justice. While underway, 58 distinguished visitors COD'ed out and received in-depth tours of the ship.

Weapons Department expended 4,700 rounds of 9mm, 255 rounds of 12 gauge, 635 rounds of M-14 and 1,890 rounds of M-16.

MAY

Air Department's V-1 division made 180 elevator runs and moved 480 aircraft. V-2 launched 353 aircraft, recovering 411. V-3 moved 161 aircraft in the hangar bay. V-4 issued 222,246 gallons of JP-5 to 237 aircraft.

AIMD's IM3 division Avionics Armament division deployed as the first afloat AIMD to support RADAR with all Consolidated Automated Support System High Power benches.

Combat System Department's CS1 division activated two satellite SHF carrier circuits on DSCS. CS3 supported the detailer visit with 11 workstations to allow telnet access to BUPERS, and certified 1,651 PKI users. CS7 division conducted CIWS PAC fire with mounts 22, 23 and 24 and launched NSSMS from launcher 1 and 2.

Public Affairs coordinated in-port tours for more than 500 visitors, including the CNO and other Navy CNO's from North and South America.

Weapons Department expended 4,700 rounds of 9mm, 3,036 rounds of .50 caliber and 21 blank rounds of M-14.

JUNE

Administration Department's Educational Service Office conducted 13 SAT tests, 20 ACT tests, 48 CLEP tests and 5 DLAB tests. Personnel issued more than 700 CAC identification cards, processed more than 150 new Sailors, transferred more than 100 personnel and separated more than 50 personnel. Command Career Counselors reenlisted 48 Sailors and processed 72 extensions.

Air Department's V-1 division made 460 elevator runs and moved 1,404 aircraft. V-2 launched 1,169 aircraft, recovering 1,167. V-3 moved 494 aircraft in the hangar bay. V-4 issued 1,949,735 gallons of JP-5 to 2,635 aircraft; 488,975 gallons were unloaded.

AIMD's IM3 division Avionics Armament division installed the Wire Braiding machine, allowing the ship the capability to repair metallic shielded F/A-18 cables. They also installed PINPOINT module repair station, upgrading the capability to troubleshoot undocumented circuit cards. IM2 division installed the Jet Engine Test Instrumentation, with four personnel certified to operate the test cell.

Combat System Department's CS2 division installed, tested and operated the Decision Support System/Common Underwater Picture (an experimental system) during Northern Edge 2004. CS3 has certified 74 percent of the ship in PKI. CS7 conducted a CIWS PACFIRE from mounts 22, 23 and 24.

Dental Department performed 11,192 dental procedures for 2,815 patients. For the crew, there were 1,472 exams, 817 fillings, 1,079 cleanings, 701 anesthetic injections, 353 x-rays, 337 extractions, 200 IV sedations, 110 root canals, and four biopsies, for a total of \$486,211 in dental care.

Engineering Department completed 891 trouble calls, utilizing 1,549 man hours, completed 102 SSA jobs expending 1,201 man hours, 993 jobs and 2,750 man hours expended in the maintenance and improvement of ship's material condition. They also manufactured numerous engravings and plaques for visiting distinguished visitors. DCCM [REDACTED] was recognized as Military Fire Officer of the Year - the Navy's number one fire fighter.

Medical Department saw 4,667 outpatients, conducted 1,524 audiograms, conducted 1,390 physical exams, performed 59 surgical procedures, did 13,152 laboratory tests, filled 15,137 prescriptions, had 1,376 physical therapy visits and 191 CAAC/Psych visits from January through June 2004.

Public Affairs coordinated in-port tours for more than 200 visitors while in Pearl Harbor Hawaii. While underway, 73 distinguished visitors COD'ed out and received in-depth tours of the ship. An additional 64 visitors COD'ed out for the day, including local media.

Weapons Department expended 4,000 rounds of 9mm, 5,600 rounds of M60 and 21 blank rounds of M-14.

JULY

Air Department's V-1 division made 367 elevator runs and moved 3,628 aircraft. V-2 launched 1,366 aircraft, recovering 1,371. V-3 moved 380 aircraft in the hangar bay. V-4 issued 2,511,226 gallons of JP-5 to 4,556 aircraft; 3,964,190 gallons were unloaded.

AIMD's IM4 division maintained a 96 percent Ready For Issue rate for 372

items of support equipment. They also processed 21 Battle Force Intermediate Maintenance Activity actions for USNS Rainier, USS Ford, USS Howard and USS Lake Champlain with embarked squadrons from HC-3, HC-11 and HSL-45. IM4 personnel completed a total of 468 preventive and corrective maintenance actions.

Combat Systems Department's CS1 division activated 5KHz Multi-National Force ACIXS net in support of RIMPAC 04. CS2 division repaired the Joint Services Imaging Processing System in CVIC. As of this month, CS3 division has certified 1,904 PKI users - the ship is 68 percent completed. CS5 division conducted Data Link Testing for battle group units. CS6 division aligned SPN-46 encoders. CS7 division conducted NATO Sea Sparrow Missile System live firing exercise. CS8 division Provided parts and technical support to Chilean Navy to participate in RIMPAC 04. They also completed 60 TV Repair trouble calls, replaced 17 telephones and replaced five Multiplexer cards.

Public Affairs coordinated in-port tours for more than 1,500 visitors while in Pearl Harbor Hawaii. While underway, 87 distinguished visitors COD'ed out and received in-depth tours of the ship. An additional 37 visitors COD'ed out for the day, including Republic of Korea media.
