- 1. 1 Jan USS KITTY HAWK is in holiday stand down. CAPT James I. Maslowski is the Commanding Officer.
 - 6 Jan Post-SLEP Availability/Selected Restricted Availability (PSA/SRA) work begins on board USS KITTY HAWK.
 - 9 Mar USS KITTY HAWK is inport undergoing a nine-day Command Inspection.
 - 7 Apr USS KITTY HAWK is underway for PSA/SRA Sea Trials. A detachment from Helicopter Anti-Submarine Squadron FOUR is embarked. Detachments from Helicopter Combat Support Squadron ELEVEN and Air Anti-Submarine Squadron THIRTY-FIVE also operate on board. The ship returns to homeport six days later.
 - 11 May USS KITTY HAWK is underway for Interim Refresher Training. The ship returns to homeport 11 days later. Carrier Air Wing Wing FIFTEEN and a detachment from Helicopter Combat Support Squadron ELEVEN are embarked.
 - 28 May USS KITTY HAWK is underway for Composite Training Unit Exercise. The ship returns to homeport 14 days later. Commander, Carrier Group ONE, Carrier Air Wing FIFTEEN, and a detachment from Marine Attack Squadron 311 are embarked. Commander, Cruiser-Destroyer Group FIVE, embarks for three days.
 - 13 Jun USS KITTY HAWK is underway for a Dependents' Day Cruise. The ship returns to homeport the same day.
 - 22 Jun CDR Paul Hennessy relieves CDR Gene Stevens as Executive Officer, USS KITTY HAWK.

<u>Narrative</u>

1. a. On 1 January 1992, USS KITTY HAWK (CV 63) is pierside at Naval Air Station North Island in holiday standdown. CAPT James I. Maslowski is the Commanding Officer.

b. On 6 January, Post-SLEP Availability/Selected Restricted Availability work begins on board USS KITTY HAWK. The purpose of the 90-day PSA/SRA is to complete renovations started during the ship's 42-month Service Life Extension Program overhaul.

c. On 9 March, Commander, Carrier Group SEVEN is on board USS KITTY HAWK to conduct a Command Inspection of the administrative operation of the ship. After nine-days the inspection is completed and KITTY HAWK receives a passing grade of satisfactory.

d. On 7 April, USS KITTY HAWK is underway for PSA/SRA Sea Trials off the Southern California coast. A detachment from Helicopter Anti-Submarine Squadron FOUR is embarked. Detachments from Helicopter Combat Support Squadron ELEVEN and Air Anti-Submarine Squadron THIRTY-FIVE operate aboard. On 12 April, the ship conducts a Burial at Sea Ceremony for CDR Richard G. McKee, USN (Ret) and LCDR Jack M. Enochs, USN (Ret). The ship returns to homeport on 13 April.

f. On 11 May, USS KITTY HAWK is underway for Interim Refresher Training. Carrier Air Wing FIFTEEN and a detachment from Helicopter Combat Support Squadron ELEVEN are embarked. CAPT Frederic Ludwig Jr. is Commander, Carrier Air Wing FIFTEEN. The ship earned satisfactory grades in all areas of damage control and combat readiness. The ship returns to homeport 11 days later.

g. On 28 May, USS KITTY HAWK is underway for Composite Training Unit Exercises. Carrier Group ONE and Carrier Air Wing FIFTEEN are embarked. RADM Joseph Prueher is Commander, Carrier Group ONE. RADM Philip Coady Jr., Commander, Cruiser-Destroyer Group FIVE, embarks for three days. A four-plane detachment from Marine Attack Squadron 311 embarks for two days to perform day and night carrier qualifications in the AV-8B Harrier II. The ship returns to homeport 14 days later.

h. On 13 June, USS KITTY HAWK is underway for Dependents' Day Cruise. This is the first such cruise in more than five years; more than 2,000 KITTY HAWK family members and guests are embarked. The ship returns to homeport the same day.

i. On 22 June, CDR Paul Hennessy relieves CDR Gene Stevens as Executive Officer. CDR Hennessy previously served as Operations Officer aboard. j. On 22 June, USS KITTY HAWK is underway for Phase Three of Exercise RIMPAC 1992, as the Flagship for Battle Force X-Ray." Carrier Group ONE, Carrier Air Wing FIFTEEN and Destroyer Squadron SEVENTEEN are embarked. Commander, Carrier Group ONE serves as the Battle Force Commander. CAPT Terry Sheffield is Commander, Destroyer Squadron SEVENTEEN. A two-plane detachment from Fleet Logistics Squadron THIRTY is also embarked. Battle Force X-Ray includes USS COWPENS, USS LEAHY, USS WILLIAM H. STANLEY, USS JARRETT, USS SACRAMENTO, and USS LOS ANGELES.

k. On 30 June, Battle Force X-Ray rendevzous with nine Japanese Maritime Self-Defense Force ships off the coast of Hawaii to conduct two days of exercise coordination and formation drills.

1. On 2 July, USS KITTY HAWK is inport Naval Station Pearl Harbor for Phase Four of Exercise RIMPAC 1992 and a five-day port visit. Units of Battle Force X-Ray are moored nearby. It is the first time in seven years that KITTY HAWK has visited Pearl Harbor. On 4 July, KITTY HAWK serves as the host ship for the CINCPACFLT 4th of July Reception. On 5 July, the ship conducts general public visiting, with more than 13,000 people visiting in nearly eight hours. On 6 July, KITTY HAWK serves as the host ship for a USCINCPAC evening social for Hawaiian Government and civic leaders.

m. On 7 July, USS KITTY HAWK is underway for Phase Five of Exercise RIMPAC 1992. Units of Battle Force X-Ray include nine ships and one submarine of the Japanese Maritime Self-Defense Force.

n. On 16 July, USS KITTY HAWK detaches from Battle Force X-Ray, and becomes the Flagship for Commander, Naval Forces, in Exercise TANDEM THRUST. Commander, Carrier Group ONE serves as Commander, Naval Forces. VMA-311 embarks aboard for the next three days, to participate in air strikes in support of a mock amphibious landing.

o. On 19 July, USS KITTY HAWK detaches from Commander, Joint Task Force in Exercise TANDEM THRUST, and resumes assignment as Flagship for Commander, Battle Force X-Ray in Phase Five of Exercise RIMPAC 1992. The ship returns to homeport five days later.

p. On 22 July, CDR Michael Cooper relieves CDR Paul Hennessy as Executive Officer. CDR Cooper previously served as Executive Officer of USS RANGER.

q. On 24 July, USS KITTY HAWK is inport San Diego for Phase Six of Exercise RIMPAC 1992. The ship is underway on 29 July for Phase Seven of RIMPAC, returning to San Diego seven days later. Also on 29 July, the ship conducts a Burial at Sea Ceremony for CAPT George Riley, USN (Ret).

r. On 1 August, USS KITTY HAWK becomes the COMNAVAIRPAC ready carrier. As ready carrier, the ship is under 96-hour alert to deploy under Commander, THIRD or SEVENTH Fleet.

s. On 31 August, USS KITTY HAWK is underway for Fleet Exercise 92-2A (FLEETEX 92-2A). Commander, Cruiser-Destroyer Group FIVE, Carrier Air Wing FIFTEEN and Commander, Destroyer Squadron SEVENTEEN are embarked. RADM Philip Coady Jr., is Commander, Cruiser-Destroyer Group FIVE. The Navy Tactical Combat System - Afloat 2.0 (NTCS-A 2.0) is employed operationally for the first time aboard an aircraft carrier. The system integrates intelligence information with anti-submarine, antisurface and anti-air warfare information. The ship returns to homeport 11 days later.

t. On 14 September, USS KITTY HAWK is underway for an Operational Propulsion Plant Examination (OPPE). Commander, Cruiser-Destroyer Group FIVE, Carrier Air Wing FIFTEEN and Commander, Destroyer Squadron SEVENTEEN are ashore. The OPPE was the first for the ship since entering the Philadelphia Naval Shipyard in July 1987. The ship earns satisfactory grades and returns to homeport four days later.

u. On 21 September, USS KITTY HAWK is underway for FLEETEX 92-2B and 92-2C. Commander, Cruiser-Destroyer Group FIVE, Carrier Air Wing FIFTEEN and Commander, Destroyer Squadron SEVENTEEN are embarked. The ship successfully completes , Supply Material Inspection (SMI), Mine Compentency Review Inspection (MCRI) and a COMNAVAIRPAC Material and Maintenance Management (3-M) Inspection; all with satisfactory grades. The ship returns to homeport 11 days later.

v. On 3 October, en route to homeport, USS KITTY HAWK participates in a Parade of Ships for Accolades 1992, an annual City of San Diego/U.S. Navy celebration in honor of the military. Upon arrival at NAS North Island, USS KITTY HAWK begins Pre-Overseas Movement (POM) standdown.

w. On 3 November, USS KITTY HAWK is underway for it's first deployment in more than five year. KITTY HAWK last deployed to the Western Pacific in January 1987. KITTY HAWK is the centerpiece of an eight ship Battle Group which includes the Guided Missile Cruisers USS COWPENS (CG 63), USS LEAHY (CG 16) and USS WILLIAM H. STANDLEY (CG 32); the Frigate USS JARRETT (FFG 33), the Replenishment Ship USS SACRAMENTO (AOE 1) and the attack submarines USS HOUSTON (SSN 713) and USS LOUISVILLE (SSN 724). The Battle Group is commanded by RADM Philip Coady, Commander, Cruiser-Destroyer Group FIVE. CAPT Terry Sheffield, Commander, Destroyer Squadron SEVENTEEN, and CAPT Frederic Ludwig, Commander, Carrier Air Wing FIFTEEN are also embarked. Additionally, on this day, the ship conducts a Burial at Sea Ceremony for LT Robert Stevenson, III, USN (Ret), GMM2 Victor Balch, USN (Ret), and CPL Seymour Schweiger, USA (Ret).

x. On 18 November, USS KITTY HAWK outchops COMTHIRDFLT and inchops into COMSEVENTHFLT's Area of Responsibility.

y. On 22 November, An F/A-18A Hornet from Strike Fighter Squadron 97 (VFA-97) impacted the water following a night carrier catapult launch. The pilot successfully ejected prior to the plane entering the water and was rescued by an SH-60F Helicopter from Helo Anti-Submarine Squadron FOUR. The pilot was not injured.

z. On 25 November, USS KITTY HAWK is anchored in the Port of Hong Kong for a five-day port visit. It is KITTY HAWK's first port visit of the deployment. More than 1200 people are given tours of the ship from 27 - 29 November. KITTY HAWK also hosts a reception on board 28 November for more than 200 people of the Hong Kong Government and local business community.

aa. On 30 November, USS KITTY HAWK is underway, en route to the Republic of Singapore.

bb. On 5 December, USS KITTY HAWK is anchored in the Port of Singapore for a five-day port visit. More than 600 people are given tours of the ship from 5 - 7 December. KITTY HAWK also hosts a diplomatic reception on board in honor of Mr. John Huntsman, U.S. Ambassador to Singapore.

cc. On 10 December, CAPT Michael McCamish, USN, relieves CAPT Frederic Ludwig, Jr., USN, as Commander, Carrier Air Wing FIFTEEN. CAPT McCamish last served as Deputy Director of Navy Program Appraisal on the staff of the Chief of Naval Operations. USS KITTY HAWK is underway, en route to turnover with USS RANGER in the Indian Ocean.

dd. On 18 December, USS KITTY HAWK relieves USS RANGER off the Coast of Somalia, and inchops into USCINCCENT Area of Responsibility. KITTY HAWK joins other multi-national forces in "Operation RESTORE HOPE," a United Nations effort to instill a secure environment for relief operations to occur in the famine stricken country of Somalia.

ee. On 20 December, USS KITTY HAWK and Carrier Air Wing FIFTEEN participate in the amphibious assault by U.S. Marines, and Belgian Paratroopers, on Somalia's southern port city of Kisamayu. Jet aircraft from Carrier Air Wing FIFTEEN make several show of force flyovers, then conduct reconnaissance and on call close air support missions in support of the amphibious forces.

ff. On 22 December, USS KITTY HAWK's Marine Detachment is sent in to Somalia's southern port city of Mogadishu to provide security for the unloading of food from relief ships. Additionally, E-2C aircraft from KITTY HAWK team with Air Traffic Controllers on board USS LEAHY and Marine Controllers on the ground to direct incoming relief flights into Southern Somalia.

gg. On 24 December, USS KITTY HAWK and Carrier Air Wing FIFTEEN provide close air support and reconnaissance for Marine Forces securing the Somali city of Oddur. hh. On 25 December, USS KITTY HAWK and Carrier Air Wing FIFTEEN provide close air support and reconnaissance for Multi-

ii. On 26 December, USS KITTY HAWK and Carrier Air Wing FIFTEEN provide close air support and reconnaissance for Multi-National Forces securing the Somali city of Gialalassi.

jj. On 27 December, USS KITTY HAWK is ordered to detach from Operation RESTORE HOPE and proceed at best speed to the Arabian Gulf. KITTY HAWK's abrupt detachment is in reaction to recent incursions by Iraqi Aircraft into the United Nations designated "No Fly" zone in Southern Iraq. Accompanying KITTY HAWK on the transit north are the USS SACRAMENTO and USS LEAHY.

kk. On 31 December, USS KITTY HAWK transits the Straits of Hormuz and into the Arabian Gulf to to assume responsibilities associated with Operation SOUTHERN WATCH.
