

COMMAND NARRATIVE FOR 1999

USS LAKE CHAMPLAIN begin her eleventh year in service in her homeport of San Diego, California under the command of Captain Paul T. Serfass Jr. The Officers and Crew were enjoying the final few days of a very rewarding and refreshing holiday stand down. The stand down period ended with a rush of activity as LAKE CHAMPLAIN begin working to prepare for the final test before the intermediate stage of the inter-deployment training cycle, the Final Evaluation Problem or FEP. LAKE CHAMPLAIN was one of the final ship's to undergo the early stages of the inter-deployment training cycle before the Chief of Naval Operations mandated inter-deployment training cycle workload reductions.

February begin with the final underway period before the graduation exercise of FEP. The week was spent validating the required items of the Tailored Ships Training Availability, requirements that had to be met before the ship could make a go for the FEP. The week was also a time of reflection as the ship conducted the first of many Burial at Seas for some of our departed shipmates from years past. The week ended with LAKE CHAMPLAIN validating FEP during the week, and moving on to the intermediate phase of training. February begin much as it ended with LAKE CHAMPLAIN underway conducting operations off the coast of California.

March was the beginning of a string of port visits that would be the highlight of the year for many of the crew members onboard LAKE CHAMPLAIN. LAKE CHAMPLAIN got underway on the 1st of March en route to San Francisco, California for a three-day port visit. The port proved close enough for many of the crews family and friends to make the trip up and enjoy the visit with them. The transit back proved equally exciting as the ship embarked Rear Admiral Campbell, Carrier Group Seven, to observe a live firing torpedo exercise with a

simulated target off San Clemente Island before pulling back into San Diego. The rest of March proved uneventful as LAKE CHAMPLAIN busied itself with many pre-deployment meetings including the first of many meetings on the upcoming C4I installation period. However, on the 19th of March the officers and crew took some time off to enjoy a Family Day Cruise with their loved ones. The final week was spent with the Naval Surface Fire Support team undergoing a team trainer conducted onboard, in preparations for the upcoming FIREX I qualification shoot.

The first week of April was spent with ear plugs in and the ship shuddering as rounds were sent down range while LAKE CHAMPLAIN very successfully completed FIREX I. Through the course of the week, LAKE CHAMPLAIN fired over 350 rounds of 5-inch ammunition. The ship returned to port on Friday with the NSFS team celebrating their victory. Later in the month, the wardroom gathered at the Bahia resort in Mission Valley for a Dining Out, the guest of honor was RADM Campbell, who help to make the event memorable for all hands. Admiral Campbell again visited the ship in late April to present the LAKE CHAMPLAIN Command retention Team with the Silver Anchor Award for their hard work throughout 1998. The final week of April was spent conducting planeguard for the first time with the USS JOHN C. STENNIS.

May was a month that many onboard had been looking forward too for many months. LAKE CHAMPLAIN would be making a trip to the great white north of Alaska and Canada towards the end of the month. However, many other operational commitments had to be met before the fun could begin. LAKE CHAMPLAIN got together with the rest of the JOHN C. STENNIS Battlegroup for the first time to participate in a Sea Combat Commander Team Trainer. The following week, LAKE CHAMPLAIN got underway to participate as opposition

forces for the CONSTELLATION Battlegroup, HSL-45 detachment 5 also embarked, giving LAKE CHAMPLAIN a chance to work with its deployment Air Department for the first time.

Having finished with all of the operational commitments, LAKE CHAMPLAIN begins her trek north for port visits in Juneau, Alaska and Victoria, British Columbia. The first stop was a five-day port visit in Juneau, the crew thoroughly enjoyed the stop, with many MWR tours arranged including fishing trips, kayaking and a trip to Mendenhall Glacier. The city of Juneau was also given a chance to see LAKE CHAMPLAIN up close as more than 400 local citizens visited for tours. Underway again on rainy Alaska morning, en route to the Straits of Juan de Fuca to meet up with a Canadian Surface Action Group for an evening of exercises before the transit into Victoria. After five days, it was underway again back to the warmer waters of Southern California and a chance to spend a few weeks at home before the demanding Battlegroup work-ups.

The months of June and July were spent preparing for the January 2000 deployment, the largest undertaking during this time was by far the IT-21 installations. LAKE CHAMPLAIN was being outfitted with some of the most technological advanced equipment ever put on surface vessels. The JOHN C. STENNIS Battlegroup would be the first Battlegroup too deploy fully IT-21 compliant. This would allow for instantaneous communications between the Battlegroup Commander as well as his subordinate commanders. It would also allow for numerous quality of life improvements including continuous e-mail while underway including individual accounts for all crewmembers. It would also allow for web surfing, putting an unimaginable amount of information at the hands of every crewmember.

However, June and July wasn't all about IT-21, there was plenty of other activities to keep the crew busy. The Battlegroup got together in early June for the first of many Air Defense

Team Trainers. In the middle of the month, the ship and shore commands of San Diego got together for some friendly sporting and nautical events during Commander, Naval Surface Forces Pacific Surface Line Week competition. The first of many meetings to discuss the Selected Restricted Availability in September of 2000 were also held onboard. The entire crew and their families getting together at Qualcomm Stadium to celebrate LAKE CHAMPLAIN day at the ballpark marked the beginning of July. LAKE CHAMPLAIN ended its inport time at the end of July getting underway to do a trail run with all of its new C4I equipment, finishing the month off with another very successful dependent's cruise for family and friends.

With the inport work complete it was time for LAKE CHAMPLAIN and the members of the JOHN C. STENNIS Battlegroup to head to sea for the first time together in order to conduct COMPTUEX 99-2. After making a brief stop at Bravo Pier to onload a Tomahawk, it was out to sea for 20 days of exercises and drills. The beginning of the underway was conducting to the members of the Battlegroup familiarizing themselves with each other and conducting some level exercise. On the 13th of August, JOHN C. STENNIS Battlegroup were the first Americans to celebrate the new millennium as the clocks were rolled ahead for a week to conduct extensive Y2K testing. LAKE CHAMPLAIN was also detached and headed up north to do a test firing of a Tomahawk missile in the Y2K environment. Despite some initial glitches, LAKE CHAMPLAIN's missile impacted at China Lake Naval Test Range and the test was a resounding success. August also marked the end of an era as LCDR Thomas C. Neal was relieved by LCDR Kerry S. Gilpin as Executive Officer.

September marked the final major inport period before Pre-overseas movement, and the last chance for major work to be completed. The month began with LAKE CHAMPLAIN undergoing Combat Systems Readiness Review having all of its combat systems equipment

checked and verified prior to deployment. September also marked the beginning of the Anthrax vaccination required of all crewmembers prior to deployment to the Arabian Gulf. The month also proved as a milestone for two of our crew as NCC(SW) [REDACTED] and FCC(SW) [REDACTED] were initiated by the chief's mess.

October was spent enjoying a week at sea without the Battlegroup, conducting many drills and exercises. The General Counsel of the Navy also paid a visit to the LAKE CHAMPLAIN in October. The crew also conducted yet another Burial at Sea off the coast. On the 28th of October the Battlegroup was again underway to participate in FLEETEX 00-1.

The final month of Battlegroup operations before deployment begin with a bang as the entire Battlegroup lined up to fire and sink an old retired naval vessel for training. The Battlegroup quickly transitioned from live firing to the artificial world of the Final Battle Problem to hone our skills in a real world situation. The entire Battlegroup pulled into San Diego on the 8th of November and immediately begin the 3-day force protection/anti-terrorism exercise. During the three days of the exercise all members of the Battlegroup were confronted with real world situations that tested the vigilance of all watch standers. Following a relaxing day off for Veterans Day the Battlegroup was underway again to conduct the final exercise of JTFEX 00-1.

Immediately after getting underway, LAKE CHAMPLAIN was directed to head north to offer protection to the BONHOMME RICHARD Amphibious Ready Group while she conducted a simulated amphibious assault off the coast of Camp Pendalton. On the 14th of November, VADM Browne, Third Fleet arrived onboard for a visit and to get a chance to meet the crew. Following the amphibious assault, LAKE CHAMPLAIN was directed to rejoin the Battlegroup for the final days of JTFEX 00-1, on the 22nd of November the Battlegroup returned to deployment having completed all of its' required pre-deployment exercises, and ready for WESTPAC 2000.

After a quick trip to Naval Weapons Station Seal Beach, California, LAKE CHAMPLAIN was ready to begin her pre-deployment stand down. With the exception of required repairs and necessary preparations the daily routine was severely reduced as the crew used the final few weeks before deployment for family time. The major work that did occur during December was the final maintenance availability, and also ship checks for both the Selected Restricted Availability and the Smart Ship installation both scheduled for September of 2000. The crew returned from the second leave period on the 28th of December and following the celebration of the new millennium the crew and officers of the LAKE CHAMPLAIN were ready for WESTPAC 2000.
