COMMAND HISTORY - 1986 USS VALLEY FORGE (CG 50)

A. COMMAND COMPOSITION AND ORGANIZATION.

USS VALLEY FORGE is the fourth ship of the new TICONDEROGA (CG 47) class Aegis guided missile cruisers. These ships are truly multi-purpose, possessing significant anti-air, anti-surface, and anti-subsurface capabilities. The Mk 7 Aegis Weapons System, the world's most capable shipboard air defense radar and missile system, enables VALLEY FORGE to provide protection for units of a carrier battle group in extreme threat environments. Hostile targets may be engaged with a variety of weapons: surface-to-air missiles, surface-to-surface missiles, ship and air launched torpedoes, antisubmarine rockets, guns, rapid fire close-in-weapons, and electronic jammers and decoys. VALLEY FORGE is well able to counter all current and projected threats to the U. S. Navy.

USS VALLEY FORGE, homeported in San Diego, CA, is a unit of Cruiser-Destroyer Group Three under Naval Surface Forces Pacific. Captain Theodore C. Lockhart is the Commanding Officer. Lieutenant Commander William V. Johnson is the Officer in Charge of HSL 43's Detachment Eight. The pilots and maintenence crew of the two LAMPS Mk III helicopters, Oceanlord 30 and 32, are embarked on VALLEY FORGE for underway periods.

C. NARRATIVE.

USS VALLEY FORGE set many new standards during her first year in commission. In 1986 the ship completed a shakedown/inspection pipeline which prepared the ship to join the Fleet at a war ready status. VALLEY FORGE earned departmental excellence awards in Operations, CIC, Gunnery, Missile Systems, Electronic Warfare, and Engineering after only six months as a Fleet asset. All inspections (Light Off Exam, Training Readiness Evaluation, Operation Propulsion Examination, Aviation Readiness Evaluation, and Final Contract Trials) were completed with outstanding grades. Additionally over 3,000 people were provided a tour onboard throughout the year.

Combat Systems Qualification Trials, supervised by Naval Ship Weapons Systems Engineering Station, were tests of the Aegis Combat System. Every warfare area was tested by firing/operating all elements of the combat system. The trials were conducted at both Hawaii and the Pacific Missile Test Ranges with outstanding results.

The Post Shakedown Availability at Todd Shipyard was conducted to accomplish Warrantee-Guarantee work items - jobs which repaired/replaced any equipment or material which had failed since construction. No major configuration changes or revisions were made to the ship.

As the extensive training and inspection cycle came to an end, VALLEY FORGE was assigned to a deploying Battle Group for Fleet operations. In November the ship participated in a two Carrier Battle Force exercise which tested the ship and crew in every way.
