USS WASP (LHD 1) is a multi-purpose amphibious assault ship whose primary mission is to embark, deploy, support and land elements of a Marine Landing Force in amphibious assault operations by helicopter, landing craft, amphibious vehicles, V/STOL or any combination of these methods. USS WASP has a secondary mission of sea control.

#### NARRATIVE

The start of 1994 found WASP in Norfolk Naval Shipyard conducting a Selected Restrictive Availability. During this extensive maintenance availability, numerous repairs and improvements were made throughout the ship. The Combat Systems suite was significantly upgraded to include the installation of the Cooperative Engagement Capability, replacement of the AN/SPS-52C three dimensional air search radar with the AN/SPS-48E, upgrading the air control radar to the AN/SPN-43C and the addition of the AN/SPN-41 controlled approach landing system for AV-8B Harrier aircraft.

By the end of April, upon completion of a highly successful Propulsion Plant Light Off Examination, WASP completed Sea Trials and returned to Norfolk Naval Station as a full up round. month of May began with a full ammunition onload followed by extensive preparations for contingency operations (Operation Support Democracy) in the Caribbean. WASP embarked COMCARGRU Eight, a Special Purpose Marine Air Ground Task Force and Commander Joint Task Force 120. In conjunction with contingency operations, WASP successfully completed Refresher Training and extensive Cooperative Engagement Capability testing which included exercise missile firings with the USS EISENHOWER Battle Group. During this period, WASP hosted numerous high level dignitaries including the Commander, United States Atlantic Command, the United States Ambassador to the Bahamas, a Congressman from the 35th district of California, and the Under Secretary of the Navy.

Upon completion of her first Caribbean contingency operations in July, WASP returned to Naval Station Norfolk for a three week Intermediate Maintenance Availability and upkeep period.

Mid August saw WASP again underway for contingency operations in the Caribbean. WASP embarked COMCRUDESGRU Twelve, a Marine Air Ground Task Force (MAGTF), and again became the flagship of Commander Joint Task Force 120 for Operation Support/Uphold Democracy off Haiti. Throughout the remainder of August and September, WASP conducted extensive preparations for combat operations in the Haitian theater. WASP participated in two amphibious assault rehearsals at Great Inagua Island and Vieques Island prior to the actual landing in Haiti. The evening of 18 September saw WASP and her embarked Marines ready in all respects for an early morning combat assault on CAP Haitian.

After an "eleventh hour" diplomatic settlement, WASP stood down and peacefully landed the MAGTF on 20 September to provide security for the general population. WASP remainded in the vicinity of CAP Haitian supporting her troops ashore. Additionally, during this time period, WASP hosted visits by the Chief of Naval Operations, the Commandant of the Marine Corps and the Secretary of Defense. Mid October saw the re-embarkation of the MAGTF, WASP's departure from the Joint Operating Area, and the end of WASP's participation in Operation "Support/Uphold Democracy". For her outstanding support of Haitian operations, WASP was awarded her second Armed Forces Expeditionary Medal, and nominated for a second Joint Meritorious Unit Commendation and the Humanitarian Services Medal. Crewmembers received 16 Navy Commendation Medals, 71 Navy Achievement Medals, and 516 Letters of Commendations. On 20 October, WASP returned to Naval Station Norfolk for a much deserved upkeep and standown period.

November and December saw WASP preparing for an upcoming Operational Propulsion Plant Examination and a change of command. On 02 December Captain R.A. Duffy relieved Captain R.C. Chaplin as Commanding Officer. Honored guests at the ceremony included the Commandant of the Marine Corps and Commander Naval Surface Force Atlantic. WASP ended 1994 moored at Naval Station Norfolk.
