HISTORY OF U.S.S. VERNON COUNTY (IST 1161) FOR THE YEAR 1964

Having completed refresher training in January with Fleet Training Group Western Pacific, VERNON COUNTY departed for Twakuni, Japan to load units of the Marine Air Control Squadron for Operation "BACK PACK" in Taiwan. February 1964 saw VERNON COUNTY to Tsoying and Kaohsuing, Taiwan and back to Naha, Okinawa to load troops for the final phases of "BACK PACK" - an operation with the Nationalist Chinese Navy.

On 25 March 1964, LCDR H. J. Nesbitt assumed command of VERNON COUNTY from CDR C. J. McCann who had been her skipper since 27 July 1962. After Amphibious Refresher Training in Numazu, Japan, VERNON COUNTY participated in Operation "LIGTAS" with the other contributing SEATO nations. The objective area was Mindoro Island in the Philippines. After a visit to the British Crown Colony of Hong Kong, VERNON COUNTY returned to Yokosuka to learn that she had been awarded a second consecutive Battle Efficiency Award as well as a Green "C" for Communications and a Green "E" for Operations excellence. Soon after came word that the ship was authorized to paint on a Red Engineering "E" making her the most honored LST in either ocean. A port visit to Kobe, Japan followed from 13 to 17 July.

A routine operation in Okinawa was cancelled in July and VERNON COUNTY proceeded to Naha, Okinawa to load units of the Third Marine Division. The next two months were spent 5 to 100 miles off the coast of Vietnam with other ships from the U.S. Amphibious Fleet. VERNON COUNTY remained on station until October when she was ordered to return to Yokosuka via Okinawa.

In November, VERNON COUNTY made a routine administrative lift

from Tsoying, Taiwan to Naha, Okinawa and back and then visited the hotsprings resort of Beppu on the island of Kyushu in Japan. Christ-mas was spent in Yokohama and New Years in Tokyo.
